CHAPTER 288.

AN ACT TO DETACH CERTAIN TERRITORY WITHIN THE INCORPORATED LIMITS AND A PART OF THE VILLAGE OF NEW PRAGUE AND ATTACH THE SAME TO THE TOWNSHIP OF LAINSBURG, COUNTY OF LE SUEUR, MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That all that certain territory or strip of land in the northeast part of the northeast quarter (‡) of section three (3), town one hundred and twelve (112), range twenty-three (23), to the extent of fifteen (15) acres, lying along the eastern boundary of, within and a part of the incorporated village of New Prague, be and the same is hereby detached and attach the same to the township of Lainsburg, county of Le Sueur, Minnesota.

SEC. 2. This act shall take effect and be in force from and after

its passage.

CHAPTER 289.

AN ACT TO AUTHORIZE THE REGISTER OF DEEDS FOR THE COUNTY OF WILKIN TO RENEW THE INDEXES OF DEEDS, MORTGAGES AND MISCELLANEOUS RECORDS OF HIS OFFICE WHICH HAVE BEEN DESTROYED BY FIRE.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the renewal of indexes of deeds, mortgages and miscellaneous records of the county of Wilkin, destroyed by fire, be made by the present register of deeds for said county, under the direction of the county commissioners thereof.

Sec. 2. That as compensation for the services to be rendered, as provided for in section one (1), the said register of deeds shall re-

ceive from said Wilkin county fifteen (15) cents per folio.

SEC. 3. That said compensation shall be paid by the county commissioners of said Wilkin county, on presentation to said commissioners by the said register of deeds of a bill for said service, subscribed and sworn to according to the law in such case made and provided.

SEC. 4. This act shall take effect and be in force from and after its

passage.

CHAPTER 290.

AN ACT TO AMEND SECTION SIX (6) OF CHAPTER TWO HUNDRED AND THIRTY-SIX (236) OF THE SPECIAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND EIGHTY-THREE (1883), RELATING TO THE MANNER OF ELECTING MEMBERS OF THE BOARD OF EDUCATION OF THE INDEPENDENT SCHOOL DISTRICT OF DULUTH, AND DEFINING THEIR POWERS.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section six (6) of chapter two hundred and thirtysix (236) of the special laws of one thousand eight hundred and eightythree (1883) be amended by adding at the end of said section the following: Any bank in the village of Duluth with a capital stock of at least thirty thousand (30,000) dollars, which desires to receive on deposit all or any portion of the funds in the hands of the treasurer of the said board of education shall, prior to September first (1st) in each year, file with the clerk of the said board an application for said deposit, stating that it will furnish good and sufficient bonds, payable to the said board of education, for double the amount of money likely to be received and conditioned for the safe keeping and payment, upon demand by the treasurer of the board, of the funds so deposited with it and interest thereon. The applications so filed shall be presented to the board of education and the board of education may then designate as the depository of the funds of the said board. one (1) or more of the said banks, or may reject any or all of the said applications. The applications aforesaid shall state the rate of interest which the various banks will agree to pay on the average daily balances of moneys so deposited in said bank, which said interest shall be credited to the account of the board of education once in each After such designation shall have been made and the bank or banks so designated shall have executed a good and sufficient bond,
