

## CHAPTER 217.

[H. F. No. 467.]

## AN ACT FOR THE RELIEF OF JAMES MCCARTHY OF DAKOTA COUNTY.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That the sum of three hundred (300) dollars be and the same is hereby appropriated out of any money in the treasury of this state not otherwise appropriated, to pay and reimburse James McCarthy of Rosemount township, in Dakota county, for personal injuries suffered and sustained by him, and for medical and other expenses incurred and made necessary from such injuries, caused by the giving way and breaking down of a defective scaffold at the capitol building of this state, then in the course of construction, and on which he was then at work as a laborer and mason's helper.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 218.

[H. F. No. 259.]

## AN ACT PROVIDING FOR A DEPUTY IN THE OFFICE OF THE PUBLIC EXAMINER, AND TO INCREASE THE CONTINGENT FUND IN THAT OFFICE.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. The public examiner may appoint a deputy who shall take and subscribe the oath of office required by law, and who shall execute to the state a bond, with two (2) or more sureties, in the penal sum of ten thousand (10,000) dollars for the faithful discharge of his duties. In case of the necessary absence or inability of the public examiner, the deputy shall perform the several duties required of that officer. Said oath and bond shall be filed in the office of the secretary of state.

SEC. 2. There is here by annually appropriated the sum of eighteen hundred (1,800) dollars out of any funds in the state treasury not otherwise appropriated, for the salary of

the said deputy, and also the further sum of seven hundred (700) dollars for clerk hire, traveling, and other expenses of the public examiner's office.

SEC. 3. This act shall take effect and be in force from and after the first day of March, A. D. one thousand eight hundred and eighty-seven (1887).

## CHAPTER 219.

[H. F. No. 335.]

### AN ACT TO APPROPRIATE MONEY FOR THE CURRENT EXPENSES OF THE STATE NORMAL SCHOOL AT SAINT CLOUD.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That the sum of one thousand (1000) dollars, in addition to the sum now allowed by law, be appropriated for the year one thousand eight hundred and eighty-seven (1887), and annually thereafter, and the same is hereby appropriated out of any money in the state treasury or which shall hereinafter come into the state treasury, not otherwise appropriated, for defraying the current expenses of said normal school.
