

CHAPTER 222.

[H. F. No. 956.]

AN ACT TO APPROPRIATE MONEY FOR THE GENERAL EXPENSES OF THE STATE GOVERNMENT FOR THE FISCAL YEAR ENDING JULY THIRTY-FIRST (31ST) ONE THOUSAND EIGHT HUNDRED AND EIGHTY-EIGHT (1888) AND ANNUALLY THEREAFTER, AND TO APPROPRIATE MONEY FOR CERTAIN GENERAL EXPENSES FOR THE FISCAL YEAR ENDING JULY THIRTY-FIRST (31ST) ONE THOUSAND EIGHT HUNDRED AND EIGHTY-EIGHT (1888) AND JULY THIRTY-FIRST (31ST) ONE THOUSAND EIGHT HUNDRED AND EIGHTY-NINE (1889.)

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the following sums of money, or so much thereof as may be necessary, are hereby appropriated from any moneys in the state treasury belonging to the general revenue fund not otherwise appropriated, for the purposes herein named, for the fiscal year ending July thirty-first (31st), one thousand eight hundred and eighty-eight (1888) and annually thereafter.

First—For executive contingent for state purposes and incidental expenses of the governor's office, three thousand dollars (\$3,000).

Second—For incidental expenses of the secretary of state's office, four hundred dollars (\$400).

Third—For incidental expenses of the office of the state auditor and land commissioners, six hundred dollars (\$600).

Fourth—For incidental expenses of the state treasurer's office, three hundred and fifty dollars (\$350).

Fifth—For incidental expenses and per diem, as allowed by law, of the attorney general, one thousand dollars (\$1,000).

Sixth—For incidental expenses and clerk hire of the public examiners office fifteen hundred dollars (\$1500).

Seventh—For incidental expenses of the office of superintendent of public instruction, one thousand dollars (\$1,000).

Eighth—For incidental expenses of the office of insurance commissioner, four hundred dollars (\$400).

Ninth—For incidental expenses of the supreme court, payable only on the order of a justice of the court, five hundred dollars (\$500).

Tenth—For incidental expenses of the adjutant general's office, two hundred dollars (\$200).

Eleventh—For clerk hire in the adjutant general's office twelve hundred dollars (\$1200).

Twelfth—For clerk hire for the governor's office, twelve hundred dollars (\$1200).

Thirteenth—For salaries of the railroad and warehouse commissioners, their secretary and clerk and for incidental expenses of the commission fourteen thousand dollars (\$14,000).

Fourteenth—For additional clerk hire in the insurance commissioner's office, six hundred dollars (\$600).

Fifteenth—For an additional amount for the salary of the military storekeeper, eight hundred dollars (\$800).

Sixteenth—For an additional amount for salary of the assistant superintendent of public instruction, three hundred dollars (\$300).

Seventeenth—For additional clerk hire in the office of the auditor and land commissioner, eighteen hundred dollars (\$1800).

Eighteenth—For additional help for care of the capitol building and grounds, two thousand dollars (\$2,000).

Nineteenth—For salary of a janitor to have charge of the supreme court room and the rooms of the judges and clerk of the supreme court, and of the state library, to be appointed by and to be under the control of the supreme court, nine hundred dollars (\$900).

Twentieth—For payment of the services of a marshal of the supreme court, four hundred dollars (400).

Twenty-first—For payment of expenses of the state board of health, five thousand dollars (\$5,000).

Twenty-second—For clerk hire in the office of superintendent of public instruction, sixteen hundred dollars (\$1600).

Twenty-third—For binding books for the law library, two hundred and fifty dollars (\$250).

Twenty-fourth—For support of the State Historical Society, six thousand dollars, (\$6000).

SEC. 2. That the following sums of money or so much thereof as may be necessary, are hereby appropriated out of any moneys in the state treasury not otherwise appropriated, belonging to the general revenue fund for the payment of certain general expenses of the state government for the fiscal year ending July thirty first (31) one thousand and eight hundred and eighty-eight (1888).

First. For the printing and binding as may be provided by contract for the five classes of printing, and for advertising for the several state departments and offices, fifteen thousand dollars (\$15,000).

Second. For the purchase of paper for public printing five thousand dollars (\$5,000).

Third. For the purchase of stationery for the several state offices, fifteen hundred dollars (\$1,500).

Fourth. For expenses examining, appraising and selling state lands, estimating and scaling pine timber and detecting trespass on state lands, seven thousand and five hundred dollars (\$7,500).

Fifth—For the payment of costs in suits instituted by the attorney general in behalf of the state, five hundred dollars (\$500).

Sixth—For the payment of expenses of requisitions of fugitives from justice, one thousand dollars (\$1,000).

Seventh—For payment of mileage of county treasurers and express and exchange charges in remitting state funds, bonds and coupons, and disbursing charges of state agents, fifteen hundred dollars (\$1,500).

Eighth—For rent of building or rooms for a state arsenal, six hundred dollars (\$600.)

Ninth—For fuel and lights, water, ice, etc., for the state capitol, three thousand dollars (\$3,000).

Tenth—For expenses and per diem of the state board of equalization, one thousand dollars (\$1,000).

Eleventh—For payment of rewards for arrests and convictions of horse thieves, five thousand dollars (\$5,000).

Twelfth—For redemption of wolf bounty orders, ten thousand dollars (\$10,000).

Thirteenth—For expenses of sheriffs conveying convicts to the state prison, fifty-five hundred dollars (\$5,500).

Fourteenth—For fees of registers and receivers of United States land offices in making abstracts of final entries of public lands for taxation, as provided by section one hundred and eighteen (118) of the general tax law, one thousand dollars (\$1,000).

Fifteenth—For expenses of hatching and distributing fish, to be expended by the fish commissioners in accordance with the act providing for the propagation of food fishes, five thousand dollars (\$5,000).

Sixteenth—For payment of claims of persons who have complied with the act of eighteen hundred and seventy-three (1873) providing for a bounty for planting trees, three thousand dollars (\$3,000).

Seventeenth—For repairs and furnishing capitol, three thousand dollars (\$3,000).

Eighteenth—For rent of telephone instruments at the capitol, one hundred dollars (\$100).

Nineteenth—For purchase of four hundred (400) copies each of volumes thirty-six (36), thirty-seven (37), thirty-eight (38) and thirty-nine (39) of the supreme court reports, thirty-two hundred dollars (\$3,200).

Twentieth—For payment of a stenographer for the offices of the governor and attorney general, twelve hundred dollars (\$1,200).

Twenty-first—For the payment of fees of referees of district courts as provided by chapter fifty-five (55) of the general laws of one thousand eight hundred and eighty-five (1885), two thousand dollars (\$2,000).

Twenty-second—For additional clerk hire in the attorney generals' office, fifteen hundred dollars (\$1,500).

SEC. 3. That the following sums of money or so much thereof as may be necessary are hereby appropriated out of any moneys in the state treasury not otherwise appropriated belonging to the general revenue fund for the payment of certain general expenses of the state government for the fiscal year ending July thirty-first (31st) one thousand eight hundred and eighty-nine (1889).

First, For printing and binding as may be provided by contract for the five classes of printing, and for advertising for the several state departments and offices, forty thousand dollars (\$40,000).

Second, For the purchase of paper for public printing, ten thousand dollars (\$10,000).

Third, For the purchase of stationery for the several state offices and for the legislature, three thousand dollars (\$3,000).

Fourth, For expenses of examining, appraising and selling state lands, estimating and scaling pine timber and detecting trespass on state lands, seven thousand and five hundred dollars (\$7,500).

Fifth, For the payment of costs in suits instituted by the attorney general in behalf of the state, five hundred dollars (\$500).

Sixth—For the payment of expenses of requisitions of fugitives from justice, one thousand dollars (\$1,000).

Seventh—For payment of mileage of county treasurers and express and exchange charges in remitting state funds, bonds and coupons and disbursing charges of state agents, fifteen hundred dollars (\$1,500).

Eighth—For rent of building or rooms for a state arsenal, six hundred dollars (\$600).

Ninth—For fuel and lights, water, ice, etc., for the state capitol, four thousand six hundred dollars (\$4,600).

Tenth—For expenses and per diem of the state board of equalization, fifteen hundred dollars (\$1,500).

Eleventh—For payment of awards for arrests and convictions of horse thieves, five thousand dollars (\$5,000).

Twelfth—For redemption of wolf bounty orders, ten thousand dollars (\$10,000).

Thirteenth—For expenses of sheriffs conveying convicts to the state prison, fifty-five hundred dollars (\$5,500).

Fourteenth—For fees of registers and receivers of United States land office in making abstracts of final entries of public lands for taxation, as provided by section one hundred and eighteen (118) of the general tax law, one thousand dollars (\$1,000).

Fifteenth—For expenses of hatching and distributing fish, to be expended by the fish commissioners in accordance with the act providing for the propagation of food fishes, five thousand dollars (\$5,000).

Sixteenth—For payment of claims of persons who have complied with the act of one thousand eight hundred and seventy-three (1873) providing for a bounty for planting trees, twenty-five hundred dollars (\$2,500).

Seventeenth—For repairs and furnishing capitol, three thousand dollars (\$3,000).

Eighthteenth—For rent of telephone instruments at the capitol one hundred dollars (\$100).

Nineteenth—For payment of a stenographer for the offices of governor and attorney general, twelve hundred dollars (\$1,200).

Twentieth—For the payment of fees of referees of district courts as provided by chapter fifty-five (55) of the general laws of one thousand eight hundred and eighty-five (1885), two thousand dollars (\$2,000).

Twenty-first—For additional clerk hire in the attorney general's office, fifteen hundred dollars (\$1,500).

CHAPTER 223.

AN ACT TO APPROPRIATE MONEY FOR CERTAIN PURPOSES THEREIN NAMED.

Be it enacted by the Legislature of the State of Minnesota:

Appropriation
for various
expenses and
deficiencies.

SECTION 1. That the following sums of money, or so much thereof as may be necessary, be, and the same are hereby appropriated from any moneys in the state treasury belonging to the general revenue fund, or that may hereafter be received to the credit of said fund.

First—For deficiency for printing, binding and advertising for the several departments and offices as provided by contract for the year ending July thirty-first (31st), one thousand eight hundred and eighty-seven (1887), the sum of twenty thousand dollars (\$20,000).

Second—For deficiency for payment of expenses of sheriffs conveying convicts to the state prison for the year ending July thirty-first (31st), one thousand eight hundred and eighty-seven (1887), two thousand dollars (\$2,000).

Third—For deficiency for payment of rewards for capture and conviction of horse thieves for the year ending
