SEC. 2. That the further sum of forty-five thousand (45,000) dollars, or so much thereof as may be necessary, is hereby appropriated out of any monies not otherwise appropriated, to be drawn and expended during the fiscal year ending July thirty-first (31st), eighteen hundred and eighty-eight (1888), for the erection, completion and furnishing of an additional building for the said school for idiots and imbeciles at Faribault; said building to be detached and separate for custodial purposes.

SEC. 3. The moneys appropriated by this act shall be paid upon warrants drawn by the president and attested by the secretary of the board of directors of the Minnesota institute for the deaf and dumb and blind, and on presentation of such warrants to the state auditor, he shall draw warrants on the state treasury for like amounts, payable to the treasurer of said board.

CHAPTER 244.

AN ACT TO APPROPRIATE MONEY FOR THE STATE PUBLIC SCHOOL FOR DEPENDENT CHILDREN.

Be it enacted by the Legislature of the State of Minnesota:

Appropriation for state public school for decendent children. Section 1. That the following sums of money be and they hereby are appropriated out of any money in the state treasury, not otherwise appropriated, for the follow-

ing purposes:

For the erection of a main building to contain general kitchen, childrens dining room, employees and superintendents dining room, reception room, superintendent's offices and vault, library, matron's room, teacher's room, store room for childrens clothing, store room for provisions, superintendent's apartments, guest chamber, sleeping apartments for employees, a chapel or assembly room, bath room, closets, &c.; for one (1) additional cottage, for one (1) school building, for one (1) hospital; for the erection of a suitable engine and boiler house; for steam heating apparatus, for heating buildings and operating steam pump; for furnishing water supply; for

water tower; for reservoir for water supply; for aparatus for the manufacture of gas for lighting buildings; for a laundry; for a sewerage, plumbing and gas fitting; for grading grounds; for the building of suitable barns and stables; for setting trees; for building fences; for purchasing teams and stock and farm machinery, &c.; the sum of thirty-five thousand (35,000) dollars for the year A. D. one thousand eight hundred and eighty-eight (1888). and thirty-five thousand (35,000) dollars for the year A. D. one thousand eight hundred and eighty-nine (1889). For the current expenses for the year one thousand eight hundred and eighty-eight (1888), twelve thousand (12,000) dollars. For current expenses for the year A. D. one thousand eight hundred and eighty-nine (1889), fifteen thousand (15,000) dollars.

CHAPTER 245.

AN ACT TO APPROPRIATE MONEY FOR HOSPITALS FOR INSANE ACCOUNT, AND FOR THE PURPOSES THEREIN NAMED.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the following sums of money, or so Appropriations much thereof as may be necessary, be and the same hereby for the hospitals for insanc. is appropriated out of any money in the state treasury not otherwise appropriated, for the following purposes.

For the hospital for the insane at St. Peter, to be drawn

from the revenue fund—

First—For right of way for railroad side track, one thousand dollars (\$1,000).

Second—For new kitchen two thousand dollars (\$2,000).

Third—For steward's office, store room and coal storage, five thousand five hundred dollars (\$5,500).

Fourth—For new water mains, three thousand dollars

That items first, second, third, and fourth shall be payable during the fiscal year ending July thirty-first (31st), one thousand eight hundred and eighty-seven (1887).
