AN ACT TO AMEND SECTION ONE (1) OF CHAPTER SEVEN (7) OF THE GENERAL STATUTES OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT (1878), RELATING TO SALARY OF THE INSURANCE COMMISSIONER'S CLERK.

Be it enacted by the Legislature of the State of Minnesota:

Salary insurance commissioner's clerk. Section 1.. That section one (1) of chapter seven (7) of the general statutes of one thousand eight hundred and seventy-eight (1878), be and the same is hereby amended so as to read as follows—

Section 1. The salary of the insurance commissioner's clerk is hereby fixed at fifteen hundred dollars

When act to take effect. (\$1500) per annum.

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 254.

[S. F. NO. 373.]

AN ACT TO LOCATE AND ESTABLISH THE THIRD HOS-PITAL FOR THE INSANE OF THE STATE OF MINNE-SOTA AND MAKING APPROPRIATION FOR THE PUR-CHASE OF LAND AND CONSTRUCTION OF BUILDINGS.

Be it enacted by the Legislature of the State of Minnesota:

Third hospital for insane.

Section 1. There is hereby located and established at the city of Fergus Falls, in the county of Otter Tail, and state of Minnesota, a hospital for the insane of the state of Minnesota, to be under the charge and control of the board of trustees for the insane of Minnesota.

Appropriation - how used.

SEC. 2. That there is hereby appropriated the sum of ninety-four thousand two hundred and eighty dollars (\$94,280) to said board of trustees, to be used as follows, viz: The sum of twenty-four thousand two hundred and eighty dollars (\$24,280) for the purchase of the following described lands, viz: The north-west quarter (NW\(\frac{1}{4}\)) of the south-east quarter (SE\(\frac{1}{4}\)); the north-west quarter

(NW₄); the south-west quarter (SW₄); and the west half (W₂) of the north-east quarter (NE₄) of section twenty-seven (27); the south half (S_2^1) of the south-west quarter (SW1) of section twenty-two (22); the south half (S½) of the south-east quarter (SE¼) of section twenty-one (21), all in township one hundred and thirtythree (133) north, range forty-three (43) west, in the county of Otter Tail, state of Minnesota—being five hundred and ninety-six (596) acres. The sum of fifty thousand dollars (\$50,000) for building and furnishing two detached wards to accommodate three hundred (300) patients, and the sum of twenty thousand dollars (\$20,000) for building a boiler-house, laundry, shops and stables, the purchase of boiler and engine, and for sewerage and water connections.

Of said appropriation forty-four thousand two hundred and eighty dollars (\$44,280) to be available at once; twenty-five thousand dollars (\$25,000) during the fiscal year ending July thirty-first (31st), one thousand eight hundred and eighty-eight (1888) and twenty-five thousand dollars (\$25,000) during the fiscal year ending July thirtyfirst (31st) one thousand eight hundred and eighty-nine (1889).

SEC. 3. This act shall take effect and be in force from When act to take effect. and after its passage.

CHAPTER 255.

AN ACT ENTITLED AN ACT TO APPROPRIATE MONEY FOR THE BENEFIT OF THE STATE NORMAL SCHOOL AT MANKATO.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That there is hereby appropriated out of Appropriation for state any money in the state treasury not otherwise appropriated, for state normal school for the fiscal year ending July thirty-first (31st), one thou- at Mankato. sand eight hundred and eighty-seven (1887), the following sums:

For repair of the Normal School building at Mankato, and for providing an additional furnace therefor, the sum of fifteen hundred (\$1,500) dollars, or so much thereof as may be necessary.
