

CHAPTER 26.

(H. F. No. 512),

AN ACT TO AMEND TITLE TWO (2) OF CHAPTER FORTY-ONE (41) GENERAL STATUTES OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT (1878), KNOWN AS THE STATUTE OF FRAUDS.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section twelve (12) of chapter forty-one (41) General Statutes of one thousand, eight hundred and seventy-eight (1878) be and the same is hereby amended by striking out the words 'or by his authorized agent,' being the last five (5) words of said section, and substituting in lieu thereof the words 'or by his lawful agent thereunto authorized in writing,' and no such contract when made by such agent shall be entitled to record, unless the authority of such agent be also recorded.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 27.

AN ACT TO AMEND SECTION NINETY (90) OF TITLE FOUR (4) OF CHAPTER THIRTY-FOUR (34) OF THE GENERAL STATUTES OF MINNESOTA, BEING SECTION TWO HUNDRED AND THIRTY-ONE (231) OF CHAPTER THIRTY-FOUR (34) OF GENERAL STATUTES OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT (1878), AS AMENDED BY CHAPTER EIGHTEEN (18) OF GENERAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND EIGHTY-ONE (1881), EXTRA SESSION, AND BY CHAPTER FORTY-ONE (41) OF GENERAL SESSION LAWS OF ONE THOUSAND EIGHT HUNDRED AND EIGHTY-THREE (1883), RELATING TO RELIGIOUS CORPORATIONS.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section ninety (90) of title four (4) of chapter thirty-four (34) of the general statutes, being section two hundred and thirty-one (231) of chapter thirty-

four (34) of general statutes one thousand eight hundred and seventy-eight (1878), as amended by chapter eighteen (18) of general laws of one thousand eight hundred and eighty-one (1881), extra session, and by chapter forty-one (41) of general session laws of one thousand eight hundred and eighty-three (1883), be and the same is hereby amended by adding at end of said section as follows:

The provision of section eighty-five (85) of this chapter, being section two hundred and twenty-six (226) of chapter thirty-four (34) of general statutes of one thousand eight hundred and seventy-eight (1878), are not to be construed as applying to or in any manner affecting corporations organized under this section. A member or director of any corporation organized under this section, may appoint in writing signed by him, a proxy to represent and act for him, and in his name and stead to vote at any meeting of such corporation or of the board of directors thereof.

Member or director of corporation may appoint proxy.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 28.

AN ACT TO AMEND SECTION ONE (1), CHAPTER ONE HUNDRED AND THIRTY-EIGHT (138), GENERAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND EIGHTY-FIVE (1885) RELATING TO TERMS OF DISTRICT COURT, ELEVENTH JUDICIAL DISTRICT.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section one (1), chapter one hundred and thirty-eight (138), General Laws of one thousand eight hundred and eighty-five (1885), be and the same is hereby amended by inserting after the word year in the fifth (5th) line of said section as printed and published in General Laws of said year, the following words:

Relating to terms of court in Eleventh Judicial District.

Provided, the judge of said court may by order made and filed with the clerk of said court at least forty (40) days prior to the fourth (4th) Monday in March in each year convene said court in general term on the fourth Monday in March of each year.

SEC. 2. This act shall take effect and be in force from and after its passage.
