## CHAPTER 49.

[S. F. No. 398.]

AN ACT TO AMEND SECTION FOUR HUNDRED AND TWELVE (412) OF CHAPTER THIRTY-FOUR (34) GENERAL STATUTES ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT (1878) RELATING TO CORPORATIONS.

*Be it enacted by the Legislature of the State of Minnesota:*

Relating to corporations.

SECTION 1. That section four hundred and twelve (412) of chapter thirty-four (34) general statutes one thousand eight hundred and seventy-eight (1878) be and the same is hereby amended by inserting after the words "manufacturing corporations" the words "and corporations for buying, holding, improving, selling, and dealing in lands, tenements, hereditaments, real, mixed, and personal estate and property."

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 50.

AN ACT TO AMEND SECTION THREE (3) OF CHAPTER EIGHTEEN (18) OF THE COMPILED STATUTES OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT (1878), RELATING TO PARTITION FENCES.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That section three (3) of chapter eighteen (18) of the compiled statutes of one thousand eight hun-

dred and seventy-eight (1878) be amended by adding the following proviso: *Provided*, That the provisions of this chapter shall not apply to the towns in Meeker county where a majority of the voters have determined pursuant to law, that horses, cattle, mules, and asses shall not be permitted to run at large.

SEC. 2: This proviso shall not apply, to partition fences on town lines in said Meeker county, where such adjoining towns have not determined pursuant to law that horses, cattle, mules, and asses shall not be permitted to run at large.

SEC. 3. This proviso shall not affect any rights heretofore acquired under section eight (8) of said chapter eighteen (18) of the said statutes of one thousand eight hundred and seventy-eight (1878).

## CHAPTER 51.

[S. F. No. 345]

AN ACT TO AMEND SECTION ELEVEN (11) TITLE THREE (3) OF CHAPTER THIRTY-FIVE (35) OF THE GENERAL STATUTES, RELATING TO TRUSTEES OF HOSPITAL FOR INSANE.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That section eleven (11) title three (3) of chapter thirty-five (35) of the general statutes of one thousand eight hundred and seventy-eight (1878) be and the same hereby is amended by striking out the word "seven" (7) at the end of the fourth (4th) line of said section and inserting in lieu thereof the word "nine" (9), and by striking out the word "four" (4) in the fifth (5th) line of said section and inserting in lieu thereof the word "five" (5.)

SEC. 2. That the two (2) additional trustees provided for in the preceding section shall on the passage hereof be appointed by the governor, by and with the advice and consent of the senate, and shall serve for the term of six (6) years from and after January first (1st), one thousand eight hundred and eighty-seven (1887), and until their successors are appointed and qualified.
