## CHAPTER 210.

[S. F. No. 370.]

AN ACT TO AUTHORIZE THE COUNTY OF NICOLLET, MINNESOTA, TO APPROPRIATE MONEY TO AID THE NICOLLET COUNTY AGRICULTURAL SOCIETY.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. The board of county commissioners of the county of Nicollet, Minnesota, is hereby authorized to appropriate a sum not exceeding five hundred (500) dollars per annum to the Nicollet County Agricultural Society, upon the application of said society, to be used exclusively for the purchase of real estate and its improvement for the use of said society, and in payment of premiums incurred in holding the annual fair of said society.

SEC. 2. All sums appropriated under section one (1) of this act shall be paid by the treasurer of said county to the treasurer of said society, upon the order of the county auditor, *Provided*, that nothing in this act shall be so construed as to compel the county commissioners to make any appropriation under this act.

SEC. 3. This act shall take effect and be in force from and after its passage.

## CHAPTER 211.

[S. F. No. 86.]

AN ACT TO AUTHORIZE THE PEOPLE OF THE TOWNSHIP OF GLENWOOD TO HOLD THEIR TOWN MEETINGS AND GENERAL ELECTIONS WITHIN THE INCORPORATE LIMITS OF THE VILLAGE OF GLENWOOD.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. Whereas the township of Glenwood in the county of Pope, did at its own expense, build and now own, a town hall, which

since the incorporation of the village of Glenwood, is included within the incorporate limits of said village; now therefore, be it enacted

SEC. 2. That the people of the said township Glenwood in the county of Pope and state of Minnesota, be, and the same are hereby authorized to hold their town meetings and general elections in the said town hall.

SEC. 3. All acts and parts of acts [inconsistent with this act are hereby repealed.

SEC. 4. This act to take effect from and after its passage.

## CHAPTER 212.

[S. F. No. 606.]

AN ACT TO AUTHORIZE THE ELECTORS OF THE TOWNSHIP OF CLEARWATER, IN THE COUNTY OF WRIGHT, TO HOLD ELECTIONS WITHIN THE INCORPORATE LIMITS OF THE INCORPORATED VILLAGE OF CLEARWATER IN SAID COUNTY.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That the electors of the township of Clearwater, in the county of Wright, are hereby authorized to establish and maintain a voting place for said township within the corporate limits of the incorporated village of Clearwater in said county. *Provided*, That said voting place shall not be so established until so ordered by a majority vote of the electors of said township voting at any annual town meeting.

SEC. 2. This act to take effect and be in force from and after its passage.

## CHAPTER 213.

[S. F. No. 89.]

AN ACT TO AUTHORIZE THE COUNTY COMMISSIONERS OF SIBLEY COUNTY TO REPAY TO JOHN GERKIN, HAMILTON BEATTY AND CHARLES COMNICK CERTAIN SUMS PAID BY THEM AS COUNTY TREASURERS OF SAID COUNTY.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That the board of county commissioners of the county of Sibley are hereby authorized to repay to Charles Comnick the sum of one hundred eighty-six dollars and sixty-three cents (\$186.63), to Hamilton Beatty the sum of one hundred ninety-one dollars and
