

## CHAPTER 251.

[H. F. No. 681].

AN ACT TO AUTHORIZE THE COUNTY OF DAKOTA, STATE OF MINNESOTA, TO LEVY A TAX UPON REAL ESTATE, LYING AND SITUATE WITHIN THE LIMITS OF THE SAID COUNTY, FOR THE CONSTRUCTION OF A ROAD UPON THE TOP OF THE BLUFF, IN A SOUTHWESTERLY DIRECTION FROM THE SOUTH LIMITS OF THE CITY OF ST. PAUL, SO AS TO INTERSECT THE SAINT PAUL AND SHAKOPEE ROAD, LEADING TO THE VILLAGE OF MENDOTA, IN THE COUNTY OF DAKOTA, STATE OF MINNESOTA, AND TO AMEND SECTION THREE (3) OF AN ACT APPROVED MARCH FIFTH (5TH), A. D. ONE THOUSAND EIGHT HUNDRED AND SEVENTY-FIVE (1885).

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That the county auditor of the county of Dakota, state of Minnesota, is hereby authorized and required to place and extend the sum of two thousand (2,000) dollars, upon the tax rolls of said county, for the year one thousand eight hundred and eighty-seven (1887), against all of the real estate liable to taxation, lying and located within the limits of said county of Dakota, as limited and prescribed in section two (2) of this act, for the construction of a road upon the top of the bluff, in a southwesterly direction from the south limits of the city of Saint Paul, so as to intersect the Saint Paul and Shakopee road leading to village of Mendota, in the county of Dakota, state of Minnesota.

SEC. 2. That the board of county commissioners of Dakota county, state of Minnesota, is hereby authorized and empowered to determine and designate the townships, districts or localities in the said county, which shall be taxed for the full sum authorized, at any time prior to the time in which it shall be the duty of the county auditor of said Dakota county to place and extend the tax upon the tax rolls of said county.

SEC. 3. The taxes authorized to be levied by this act shall be collected and paid as other taxes are collected and paid in said county of Dakota, and as soon as the said taxes are collected and paid to the county treasurer of said Dakota county, it shall be the duty of the county auditor of said county of Dakota, to draw and issue a warrant upon the county treasurer of said county for the amount of the tax, so collected, in favor of the city treasurer of the city of Saint Paul, county of Ramsey, Minnesota, taking the receipt of the said city treasurer for the said warrant.

SEC. 4. This act shall not in any way or manner affect sections one (1) and two (2) of an act approved March fifth (5th), A. D. one thousand eight hundred and eighty-five (1885), entitled, "An act to authorize the county of Dakota, state of Minnesota, to levy a tax upon the real estate in the townships of Burnsville, Egan and Mendota for the purpose of grading and bridging the

St. Paul and Shakopee wagon road from the village of Mendota to the city limits of St. Paul, Minnesota."

SEC. 5. That section three (3) of an act approved March fifth (5th), A. D., one thousand eight hundred and eighty-five (1885), being the act referred to in section four (4) of this act, be amended so as to read the same as section three (3) of this act.

SEC. 6. That the common council of the city of Saint Paul shall have absolute control in making the contemplated improvement, and no contract shall be entered into until after the said road is laid out and is a legal road, and the right of way vested in the public.

SEC. 7. That the two thousand (2,000) dollars authorized by this act, and the two thousand (2,000) dollars authorized by an act approved March fifth (5th), A. D., one thousand eight hundred and eighty-five (1885), referred to in section four (4) of this act, aggregating a total sum of four thousand (4,000) dollars, shall form a part of the twelve thousand (12,000) dollars which the city of Saint Paul is authorized to expend in making the said improvement under the provisions of an act passed at the present session of the legislature in the year one thousand eight hundred and eighty-seven (1887).

SEC. 8. This act shall take effect and be in full force from and after its passage.

## CHAPTER 252.

[H. F. No. 50.]

AN ACT AUTHORIZING AND REQUIRING EACH TOWN AND VILLAGE  
IN POPE COUNTY TO SUPPORT ITS OWN POOR.

*Be it enacted by the Legislature of the State of Minnesota;*

SECTION 1. That each town and incorporated village in the county of Pope, shall support all poor persons in the town or village, and the board of supervisors of each town and the village council of each village in said county shall have entire and exclusive superintendence of the poor of their respective towns or villages.

SEC. 2. The electors of each town in said county shall, at their annual town meeting in each year, and the village council at their first meeting in August each year, vote to raise such sum of money for the support of the poor as they may deem expedient, which facts the town clerk and village recorder shall certify to the county auditor at the same time that other taxes are certified. The county auditor of said county shall assess and levy upon the taxable property of each town or village in said county such sums raised by each town for said purpose.
