

CHAPTER 262.

[S. F. No. 71.]

AN ACT AMENDING SECTION TWO (2), CHAPTER ONE HUNDRED AND FORTY-FOUR (144) OF SPECIAL LAWS OF THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-ONE (1881), IN RELATION TO A SCHOOL DISTRICT IN SIBLEY COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. Section two (2) of chapter one hundred and forty-four (144), special laws of the year of our Lord one thousand eight hundred and eighty-one (1881), is hereby amended by striking out the words, "and the northeast quarter ($\frac{1}{4}$) of the southeast quarter ($\frac{1}{4}$) of section number three (3)," where the same occur in the first (1st) four (4) lines of the paragraph describing the boundaries of school district number forty-two (42).

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 263.

AN ACT TO DETACH CERTAIN TERRITORY FROM THE VILLAGE OF JANESVILLE, IN WASECA COUNTY, IN THE STATE OF MINNESOTA, AND TO ATTACH THE SAME TO THE ADJOINING COMMON SCHOOL DISTRICTS.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the south-west quarter of section twenty-six (26), the south-east quarter of section twenty-seven (27), the north-east quarter ($\frac{1}{4}$) of section thirty-four (34), all of the north-east quarter ($\frac{1}{4}$) of the south-east quarter ($\frac{1}{4}$) of section thirty-four (34), north of the Winona and St. Peter railroad track, the north-west quarter ($\frac{1}{4}$) of the north-west quarter ($\frac{1}{4}$) of section thirty-five (35), the east one half ($\frac{1}{2}$) of section thirty five (35), the east one half ($\frac{1}{2}$) of the west one half ($\frac{1}{2}$) of section thirty five (35), excepting from the last named piece or parcel a strip of land in the south-west corner thereof, thirty-seven (37) rods long, east and west, by fifteen (15) rods wide, north and south, all in township one hundred and eight (108), range twenty-four (24), in Waseca county, Minnesota, and now being a part

of the village of Janesville, in said county, be and the same is hereby detached from the said village of Janesville, and attached to and made a part of common school district number twenty-nine (29), in said county of Waseca. And that the south-east quarter ($\frac{1}{4}$), the north-west quarter ($\frac{1}{4}$) of the north-east quarter ($\frac{1}{4}$) and the north-east quarter ($\frac{1}{4}$) of the north-west quarter ($\frac{1}{4}$), all in section three (3), township one hundred and seven (107), range twenty-four (24), in said county of Waseca and state of Minnesota; now being a part of said village of Janesville be and the same is hereby detached from said village of Janesville and made a part of, and attached to common school district number sixty two (62), in said county of Waseca.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 264.

AN ACT TO DETACH SECTION TWENTY-EIGHT (28) IN TOWNSHIP ONE HUNDRED AND FIFTEEN (115), RANGE THIRTY-THREE (33) IN RENVILLE COUNTY FROM SCHOOL DISTRICT NUMBER SIXTY-FOUR IN SAID COUNTY, AND ATTACH THE SAME TO SCHOOL DISTRICT NUMBER ONE HUNDRED (100) IN SAME COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section twenty-eight (28) township one hundred and fifteen (115), range thirty-three be and the same is hereby detached from school district number sixty-four (64) in Renville county, and attached to school district number one hundred (100) in said Renville county.

SEC. 2. This act shall take effect and be in force from and after its passage.
