the vacation of streets and alleys in said city, which has received the approval of the mayor of said city, is hereby legalized, ratified and confirmed.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 288.

[S. F. No. 360.]

AN ACT LEGALIZING THE VOTE OF THE VOTERS OF CHASKA INDE-PENDENT SCHOOL DISTRICT IN CARVER COUNTY, IN REGARD TO THE INSURANCE OF CERTAIN BONDS FOR THE PURPOSE OF ERECTING A SCHOOL BUILDING, AND THE ISSUE MADE THERE-UNDER, AND AUTHORIZING THE ISSUANCE THEREUNDER OF AD-DITIONAL BONDS BY SAID DISTRICT FOR SUCH PURPOSE.

Whereas, The question of the issuance of the bonds of Chaska Independent School District in the county of Carver, in the sum of nine thousand five hundred (9,500) dollars, for the purpose of erecting a school building for said district, was duly submitted to the legal voters of said district and the vote of said electors taken and properly canvassed, and declared to be carried in favor of the issuance of such bonds.

AND WHEREAS, Pursuant thereto, the bonds of said district in the sum of six thousand (6,000) dollars have been issued, and there remains unissued, of the amount thus authorized to be issued, the sum of three thousand five hundred (3,500) dollars. Therefore,

Be it enacted by the Legislature of the state of Minnesota:

Section 1. That all and singular, the acts and proceedings of said Chaska Independent school district and the board of education thereof, in submitting to the legal voters of said district the propositions in regard to the issuance of bonds for the purpose of building a school building for said district, as well as the canvass of the vote, and the making declaration thereof, and the issuance of bonds in pursuance thereof in the sum of six thousand (6,000) dollars, together with the manner, form and order of issuing the same and the mode of the execution thereof, be and the same are hereby legalized and made valid.

Sec. 2. The board of education of said district is hereby authorized to issue the bonds of said district under and pursuant to the vote of the electors of said district as so had and taken, in the additional sum of three thousand five hundred (3,500) dollars. Such bonds shall be executed in the same manner that the bonds of said district

heretofore issued were executed, and shall bear interest at the rate of seven (7) per cent. per annum, and be payable within ten (10) years

from the date of the issuance thereof.

SEC. 3. The provisions of chapter [number] one hundred and five (105), of the special laws of one thousand eight hundred and seventy-five (1875), relating to the manner of providing for the payment of the bonds of said district, shall apply to the bonds issued pursuant thereto.

SEC. 4. This act shall take effect and be in force from and after its passage.

## CHAPTER 289.

[S. F. No. 614.]

AN ACT TO LEGALIZE THE INCORPORATION OF THE VILLAGE OF HERMAN, GRANT COUNTY, MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota.

Section 1. That all acts taken for the incorporation of the village of Herman in Grant county, Minnesota, and all acts taken and proceedings had for the incorporation of the said village, are hereby made valid and effectual, and said village is hereby declared to be a duly incorporated village under the general law of A. D. one thousand eight hundred and eighty-five (1885) relating to the incorporating of villages, and shall possess and be endowed with all the franchises, rights, powers and privileges and subject to all the duties in said law of A. D. one thousand eight hundred and eighty-five (1885) enumerated and contemplated. And all votes taken by the electors of said village, and all official acts and proceedings of all persons heretofore acting as officers of said village, are hereby legalized and declared to be of the same force and validity as if legal and valid in their inception.

SEC. 2. This act shall take effect and be in force from and after

its passage.
