dollars, to be paid as hereinbefore named, for like services in his office as provided for in section one (1) of this act in relation to the

auditor of said county.

That section six (6) of "an act to amend the city charter of the city of Saint Paul and the acts amendatory thereof," approved February twenty-second (22d), one thousand eight hundred and eighty-seven (1887), is hereby amended by striking out the word "second" (2d), before the word Tuesday and inserting in lieu thereof the word "first" (1st).

SEC. 4. The jailor of the city of Saint Paul shall receive as com-

pensation for his services nine hundred (900) dollars per annum.

The market master of the city of Saint Paul shall receive as his compensation for his services, twelve hundred (1,200) dollars per annum.

SEC. 6. This act shall take effect and be in force from and after

its passage.

## CHAPTER 334.

(S. F. No. 116.)

AN ACT FOR AN ACT ENTITLED, AN ACT TO REDUCE THE NUM-BER OF COUNTY COMMISSIONERS IN THE COUNTY OF WASECA FROM SIX (6) TO FIVE (5), TO LIMIT THE COMPENSATION OF SUCH COUNTY COMMISSIONERS AND TO RE-ARRANGE THE COMMIS-SIONER DISTRICTS OF SAID COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. The board of county commissioners of the county of Waseca shall be composed of five (5) members, one (1) of whom shall be chosen from each of the commissioner districts hereinafter provided for.

Sec. 2. Commissioner district number one (1) shall comprise the

towns of Otises, New Richland and Byron, in said county.

Commissioner district number two (2) shall comprise the city of Waseca, in said county.

Commissioner district number three (3) shall comprise the towns of Woodville, Blooming Grove and Iosco in said county.

Commissioner district number four (4) shall comprise the towns of St. Mary, Alton and Janesville, in said county.

Sec. 6. Commissioner district number five (5) shall comprise the

towns of Freedom, Wilton and Vivian, in said county.

. Sec. 7. The members of said board shall receive the same com-, pensation as is now provided by law for the county commissioners of Waseca county, provided that no member of said board shall receive, in any one (1) year, compensation for services for any greater number of days than twenty five (25) days.

SEC. 8. All acts or parts of acts inconsistent with the foregoing

are hereby repealed.

SEC. 9. This act shall take effect and be in force from and after its passage.

## CHAPTER 335.

(S. F. No. 168.)

AN ACT TO REGULATE THE CATCHING OF FISH IN ALBERT LEA, FOUNTAIN, PICKEREL AND WHITE'S LAKES, AND THE STREAMS CONNECTED THEREWITH, IN THE COUNTY OF FREEBORN, AND TO REGULATE THE HUNTING OF CERTAIN WILD GAME THEREIN.

Be it enacted by the Legislature of the State of Minnesota.

Section 1. That it shall be unlawful for any person or personst o take, catch, kill or destroy, any fish known as pike, pickerel, bass, croppies, or perch, or any other kind of fish, in or from the waters of Albert Lea lake, Fountain lake, Pickerel lake and White's lake, or the outlets, inlets, creeks, or streams connected with said lakes, in the towns of Albert Lea, Pickerel Lake and Shell Rock, in the county of Freeborn in said state, by means of spearing or shooting them, or by the use of any dip or gill-net, seine, drag-net, or by any other means, or in any manner, than by angling for them with hook and line, and it shall be unlawful, for any person to obstruct by any trap, net, or any other device or contrivance placed across the narrow places or streams of the waters, outlets, or inlets aforesaid, to prevent the free passage of fish through or therein, and such traps, nets, or contrivance so placed, are declared a nuisance, and may be removed or destroyed by any person, and provided, that it shall be unlawful for any person or persons to take, catch, kill, or destroy in any manner whatever, except as provided herein for the purpose of selling, vending, or giving away, any of the kind of fish named in this act, or any other kind of fish in or from any of the waters, outlets, inlets or streams aforesaid, between the first day of December, and the first day of May of any year, for a period of four (4) years from January 1st, 1887. Provided, further, that nothing in this act shall prevent any one from catching any of the above named fish by angling with one single hook, properly. baited, when the same is used for his own individual or family use.

SEC. 2. That it shall be unlawful, for any person or persons, to kill, shoot, wound or destroy in any manner, any wild duck, goose or
