# CHAPTER 385.

#### [H. F. No. 827.]

### AN ACT TO FIX A PER DIÉM FOR THE COUNTY COMMISSIONERS OF POLK COUNTY, AND TO ALLOW THE TREASURER OF SAID COUNTY CLERK HIRE NOT TO EXCEED ONE THOUSAND DOLLARS (\$1000) PER YEAR.

#### Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the county commissioners of the county of Polk, shall each receive three dollars (\$3) per day for each day neccessarily employed as the county board of said county, not to exceed thirty(30) days in any one year; and ten (10) cents per mile for every mile traveled in going to and returning from the meeting of the county board in the discharge of official duty, the mileage so traveled to be computed by the nearest traveled route.

SEC. 2. That in addition to the compensation above provided for, any county commissioner of said county, which already and necessarily employed in the business of the county referred to him as a committee or commissioner in charge of any matter pertaining to the business or interests of the county, may charge and shall receive pay at the rate of three dollars (\$3) per day for each day so employed and ten (10) cents per mile for every mile traveled in the performance of such duty.

SEC. 3. That the county treasurer of Polk county shall be allowed clerk hire not to exceed one thousand dollars (\$1000) in any one year, to be paid to such clerks monthly on the warrant of the county Auditor.

SEC. 4. All acts or parts of acts inconsistent herewith are hereby repealed.

SEC. 5. This act shall take effect and be in force from and after its passage.

## CHAPTER 386.

[H. F. No. 676.]

### AN ACT TO ESTABLISH CITY JUSTICES OF THE PEACE IN THE CITY OF MINNEAPOLIS.

#### Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. There shall be elected at the next municipal election to be held in the city of Minneapolis, three (3) justices of the peace. Said justices of the peace shall hold their offices for two (2) years from and after their election, or until their successors are elected. They shall be elected from the following parts of the city, to-wit: One (1) from that portion of the city lying north of First Avenue South and west of the Mississippi river; one (1) from that part of the city lying • south of First Avenue South and west of the Mississippi river; and one (1) from that part of the city lying east of the Missippi river.

SEC. 2. Said justices of the peace shall be elected at said election by the voters of the said parts of the city as specified in section one (1) of this act. And no voter shall vote for any justice outside of that part of the city in which both justice and voter reside. Said justices must be residents of the districts from which they are elected.

SEC. 3. The said justices, and each of them, shall have jurisdiction of all civil suits involving one hundred dollars (\$100) or less, and their jurisdiction and practice shall be the same as all justices of the peace in the state of Minnesota, being regulated by the general laws, revision of one thousand eight hundred and seventy-eight (1878). *Provided*, that their jurisdiction shall not extend to any person outside of the city limits of the city of Minneapolis.

SEC. 4. Appeals shall be made to the district court as in other cases.

SEC. 5. All acts or parts of acts conflicting with the above are hereby repealed.

Sec. 6. This act shall take effect and be in force from and after its passage.

# CHAPTER 387.

[H. F. No. 735.]

### AN ACT CONSTITUTING THE VILLAGE OF TRACY, IN LYON COUNTY, AN ELECTION DISTRICT.

#### Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The village of Tracy, in Lyon county, is hereby constituted an election district.

SEC. 2. All general and special elections in said village shall be conducted by the trustees of said village, who shall be the judges of election, and the village recorder who shall be clerk of election, and they each shall take the usual oath, as prescribed by the general laws of the state to be taken by the judges and clerks of elections, and they, the trustees, shall have power to appoint clerks of election and to administer all necessary oaths. All elections shall be held and conducted in the same manner and under the same penalties as is
