and after their election, or until their successors are elected. They shall be elected from the following parts of the city, to-wit: One (1) from that portion of the city lying north of First Avenue South and west of the Mississippi river; one (1) from that part of the city lying south of First Avenue South and west of the Mississippi river; and one (1) from that part of the city lying east of the Missippi river.

SEC. 2. Said justices of the peace shall be elected at said election by the voters of the said parts of the city as specified in section one (1) of this act. And no voter shall vote for any justice outside of that part of the city in which both justice and voter reside. Said justices must be residents of the districts from which they are elected.

SEC. 3. The said justices, and each of them, shall have jurisdiction of all civil suits involving one hundred dollars (\$100) or less, and their jurisdiction and practice shall be the same as all justices of the peace in the state of Minnesota, being regulated by the general laws, revision of one thousand eight hundred and seventy-eight (1878). Provided, that their jurisdiction shall not extend to any person outside of the city limits of the city of Minneapolis.

Sec. 4. Appeals shall be made to the district court as in other

cases.

Sec. 5. All acts or parts of acts conflicting with the above are

hereby repealed.

Sec. 6. This act shall take effect and be in force from and after its passage.

CHAPTER 1387.

[H. F. No. 735.]

AN ACT CONSTITUTING THE VILLAGE OF TRACY, IN LYON COUNTY, AN ELECTION DISTRICT.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The village of Tracy, in Lyon county, is hereby constituted an election district.

SEC. 2. All general and special elections in said village shall be conducted by the trustees of said village, who shall be the judges of election, and the village recorder who shall be clerk of election, and they each shall take the usual oath, as prescribed by the general laws of the state to be taken by the judges and clerks of elections, and they, the trustees, shall have power to appoint clerks of election and to administer all necessary oaths. All elections shall be held and conducted in the same manner and under the same penalties as is

provided by the laws of this state, regulating the holding of elections, and the judges and clerks of said elections shall receive the same fees for their services, as is allowed township supervisors for acting as judge at general elections.

SEC. 3. This act shall take effect and be in force April first (1st)

AN ACT TO CHANGE THE NAME OF SNAKE LAKE, IN RAMSEY COUNTY, TO THAT OY LAKE AVOCA.

SECTION 1. That the name of Snake Lake, in Ramsey county, be and the same is hereby changed to that of Lake Avoca, and by which name it shall hereafter be known.

CHAPTER 389.

AN ACT EMPOWERING JUSTICES OF THE PEACE IN SOUTH STILL-WATER AND IN THE TOWN OF BAY TOWN, WASHINGTON COUNTY, MINNESOTA, TO TAKE JUDICIAL NOTICE OF THE BY-LAWS AND OBDINANCES OF THE VILLAGE OF SOUTH STILLWATER, AND DECLARING SAID BY-LAWS OF FORCE AND EFFECT.

Be it enacted by the Legislature of the State of Minnesota.

SECTION 1. That all justices of the peace, and village justices, in the village of South Stillwater, and in the town of Bay Town, Washington county, Minnesota, be, and they are, hereby authorized and required in all proceedings before such justices of the peace, to take judicial notice of all the by-laws and ordinances of the village of
