CHAPTER 79.

AN ACT TO AMEND CHAPTER SIX (6) OF SPECIAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-FIVE (1875), BEING THE CHARTER OF THE CITY OF SHAKOPEE.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Section two (2) of chapter two (2) of chapter six (6) of special laws of one thousand eight hundred and seventy-five (1875) is hereby amended by striking out the word "recorder" in the second

line of said section two (2).

- SEC. 2. Section four (4) of chapter three (3) of said chapter six (6) of special laws of one thousand eight hundred and seventy-five (1875), is hereby amended by inserting immediately after the words, "city recorder" in the first (1st) and second (2d) lines of said section, the words, "who shall be appointed by the common council at the first (1st) meeting after each biennial election, whose term of office shall be two (2) years and until his successor is appointed and qualified."
- SEC. 3. Section seventeen (17) of said chapter three (3) of chapter six (6) special laws of one thousand eight hundred and seventy-five (1875), is hereby amended by inserting immediately after the word "officer," in the sixth (6th) line thereof, the words, except "city recorder."
- SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER 80.

AN ACT TO AMEND CHAPTER ONE HUNDRED AND THIRTY-FIVE (135) OF THE SPECIAL LAWS OF MINNESOTA OF ONE THOUSAND EIGHT HUNDRED AND EIGHTY-THREE (1883).

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That sections one (1) and five (5) of chapter one hundred and thirty-five (135) of the special laws of one thousand eight hundred and eighty-three (1883) be amended by inserting after the word "Norman," where it appears in the third (3d) line of said section one (1), and in the second line of said section five (5) the words "Becker, Big Stone, Blue Earth, Chippewa, Cottonwood, Fari-

bault, Fillmore, Grant, Houston, Jackson, Kandiyohi, Lac qui Parle, Murray, Mower, Dodge, Otter Tail, Sibley, Stearns, Steele, Stevens, Traverse."

SEC. 2. This act shall take effect and be in force from and after its passage.

Be it Enacted by the Legislature of the State of Minnesota:

SECTION 1. That section three (3) of an act entitled an act to authorize the city of Minneapolis to issue bonds for bridges be and the same is hereby amended by striking out the words "stone arch," wherever they occur in said section and by inserting in the place thereof the words "iron or steel arch."
