suing bonds, Yes," or the words, "In favor of issuing bonds, No." If the majority of the votes cast at said election is in favor of the issue of said bonds, then and in that case the village council of said village shall have power to issue said bonds, and not otherwise.

SEC. 7. This act shall take effect and be in force from and after its passage.

## **CHAPTER** 235.

[H. F. No. 783.]

### AN ACT AUTHORIZING THE VILLAGE OF RENVILLE, TO ISSUE BONDS TO AID IN BUILDING COUNTY BUILDINGS AT THE VIL-LAGE OF RENVILLE, IN RENVILLE COUNTY, MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The village of Renville, in the county of Renville, and state of Minnesota, is hereby authorized and empowered to issue its bonds for the purpose of aiding the county of Renville in erecting a court house and jail at the village of Renville, in said county; said bonds shall be issued in such denominations as the village council of said village may see fit not to exceed the sum of five hundred (500) dollars each, and in the aggregate not to exceed the sum of ten thousand (10,000) dollars, to become due in not more than twenty (20) years from the date thereof, and bearing interest at the rate of not more than seven (7) per cent. payable annually.

SEC. 2. The proposition to issue said bonds shall be submitted to a vote of the electors of said village at any annual election held after the passage of this act or any duly called special election of said village called for that purpose.

The ballots to be voted at such election shall have written or printed or partly written and partly printed upon them the words, "In favor of issuing bonds," or the words, "Against issuing bonds." If a majority of such ballots are, "In favor of issuing bonds," the village shall issue said bonds, as hereinafter provided. *Provided*, that notice of the submission of the proposition to issue said bonds shall be given by the village recorder in the notice of the annual or special election at which said proposition is to be submitted.

SEC. 3. The said bonds shall be issued by the village council, signed by the president and attested by the village recorder, for the use and benefit of the county of Renville, whenever the county commissioners of said county shall determine and do proceed towards the erection of a court house and jail for said county at the village of Renville.

SEC. 4. The village council of said village are hereby empowered

to and shall annually after the issue of said bonds levy a tax upon the taxable property of said village sufficient to pay the interest on said bonds as it shall become due and any tax levied and collected for this purpose shall not be used for any other purpose until the whole of said bonds both principal and interest are paid.

SEC. 5. This act shall take effect and be in force from and after its passage.

# CHAPTER 236.

[H. F. No. 716.]

AN ACT ENTITLED AN ACT TO AUTHORIZE THE CITY COUNCIL OF THE CITY OF WEST SAINT PAUL TO ISSUE BONDS.

#### Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That authority is hereby granted to the city council of West Saint Paul to issue bonds not to exceed the sum of five (\$5,000) thousand dollars, for the purpose of purchasing real estate and erecting thereon city hall, jail and other purposes.

The bonds herein provided for shall be of the denomination of not less than five (\$500) hundred dollars each, with interest coupons attached, and shall be payable in not less than ten (10) years after date, with interest not to exceed six (6) per cent per annum payable at such financial agency as the city of West Saint Paul may select. None of said bonds shall be sold or negotiated for less than par.

SEC. 2. This act shall take effect and be in force from and after its passage.

# CHAPTER 237.

[H. F. No. 789.]

AN ACT TO AUTHORIZE THE BOARD OF EDUCATION OF THE BRAIN-ERD SCHOOL DISTRICT TO ISSUE BONDS FOR THE PURPOSE OF PROVIDING ADDITIONAL SCHOOL HOUSES, GROUNDS AND FUR-NITURE.

### Be it enacted by the Legislature of the State of Minnesota.

SECTION 1. The board of education of the Brainerd school district, in the county of Crow Wing and state of Minnesota, is hereby authorized and fully empowered to issue the bonds of said district, with coupons, to an amount not exceeding the sum of thirty-five thous-
