CHAPTER 266.

AN ACT TO AMEND AN ACT ENTITLED "AN ACT TO AUTHORIZE THE COUNTY OF RAMSEY AND THE CITY OF SAINT PAUL TO ISSUE BONDS TO BUILD AN ALMS HOUSE AND HOSPITAL, AND FOR OTHER PURPOSES, APPROVED FEBRUARY TWENTY-NINE (29), ONE THOUSAND EIGHT HUNDRED AND SEVENTY-TWO (1872)," AND THE ACTS SUPPLEMENTAL THERETO AND AMENDATORY THEREOF.

Be it enacted by the Legislature of the State of Minnesota.

Section 1. That section four (4) of the act of February twenty-nine (29) one thousand eight hundred and seventy-two (1872), entitled "An act to authorize the county of Ramsey and the city of Saint Paul to issue bonds to build an alms house and hospital, and for other purposes," is hereby amended by striking out the following words, "said physician to furnish all necessary medicine for patients without extra charge, in consideration whereof said physician is to be furnished an office either in the building aforesaid or on the ground adjacent thereto," and all acts and parts of acts amendatory of said act of February twenty-nine (29), one thousand eight hundred and seventy-two (1872), or otherwise, in so far as they require the city and county physician to furnish medicines, are hereby repealed.

SEC. 2. That said city and county physician is hereby relieved from any claim of said city and county, for any of said medicine furnished since February twenty-fifth (25th), one thousand eight hun-

dred and eighty-seven (1887).

SEC. 3. All acts and parts of acts inconsistent with the provisions

of this act are hereby repealed.

SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER 267.

[H. F. No. 428.]

AN ACT TO AUTHORIZE THE CITY OF SAINT PAUL TO ISSUE BONDS FOR THE ERECTION OF ADDITIONAL BUILDINGS, HEATING PLANT, ETC., FOR HOSPITAL PURPOSES.

Be it enacted by the Legislature of the State of Minnesota.

SECTION 1. That to provide means for the erection of additional buildings, heating plant, etc., for hospital purposes the common coun-

cil of the city of Saint Paul is hereby authorized and empowered to issue and negotiate the bonds of the city of Saint Paul for the amount in the aggregate of one hundred thousand (\$100,000) dollars, or as much thereof as may be required for the erection of additional build-

ings, steam plant, etc., for hospital purposes.

Sec. 2 Said bonds shall be issued at such times as the common council may order and direct, with the approval of the mayor, and shall be of the denomination of one thousand dollars (\$1000) each, and shall be payable thirty (30) years after their date, with interest at the rate not to exceed five (5) per cent per annum, payable semi-annually at the financial agency of the city of Saint Paul in the city of New York. None of said bonds shall be sold or negotiated for less than par.

SEC. 3. Said bonds are to be issued and the proceeds thereof used and expended as provided in an act of the legislature of this state entitled "an act in relation to the erection of public buildings for the use of the city of Saint Paul and the county of Ramsey for hospital purposes in the city of Saint Paul, and the appointment of special commissioners with respect thereto," approved February twenty-second (22), eighteen hundred and eighty-seven (1887), and the special commissioners appointed by said act last aforesaid, are hereby continued in office, with the same powers, duties, compensation and obligations to carry into effect the purposes of this act, and all the provisions of said act of eighteen hundred and eighty-seven (1887) applicable to the use and expenditure of the fund created by this act, are hereby continued in force for that purpose.

Provided, however, that the additional buildings, heating plant, etc., to be erected with the funds provided by this act, may be located on the block mentioned in said act of eighteen hundred and eighty-seven (1887), or on property adjacent thereto, or both, as said commissioners may elect by and with the consent of said common council.

SEC. 4. This act shall take effect and be in force from and after

its passage.

CHAPTER 268.

AN ACT TO AUTHORIZE THE BOARD OF EDUCATION OF THE CITY OF SAINT PAUL TO ISSUE ITS BONDS TO THE AMOUNT OF TWO HUNDRED THOUSAND (200,000) DOLLARS TO AID IN THE ERECTION OF THE PUBLIC SCHOOL BUILDINGS OF SAID CITY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the board of education of the city of Saint Paul is hereby authorized and empowered to issue and negotiate its bonds to the amount of two hundred thousand (200,000) dollars, for the
