

CHAPTER 306.

[S. F. No. 829.]

AN ACT TO AUTHORIZE THE WINONA AND SOUTHWESTERN RAILWAY COMPANY TO CONSTRUCT AND MAINTAIN A BRIDGE ACROSS THE MISSISSIPPI RIVER AT THE CITY OF WINONA, MINNESOTA.

WHEREAS, the Winona and Southwestern Railway Company, a corporation of the state of Minnesota, has been duly authorized to construct and maintain a bridge at the city of Winona, Minnesota, by an act of Congress approved August thirteenth (13th), one thousand eight hundred and eighty-eight (1888), entitled "An act to authorize the Winona and Southwestern Railway Company to build a bridge across the Mississippi river at Winona, Minnesota, therefore

Be it enacted by the Legislature of the State of Minnesota.

SECTION 1. That the said Winona and Southwestern Railway Company, its successors and assigns, be and is hereby authorized and empowered to construct and maintain such bridge with all necessary approaches thereto, or cause the same to be constructed and maintained from any feasible point in said city of Winona, to a point on the opposite bank of said river in the state of Wisconsin. Any bridge to be built under the authority of this act shall conform to the requirements of the said act of congress authorizing the same, and may be either a railroad bridge, or a combined railroad and wagon bridge.

SEC. 2. The said Winona and Southwestern Railway Company, its successors and assigns, may acquire by purchase or by condemnation, by the exercise of the right of eminent domain in the manner prescribed in chapter thirty-four (34) of the general statutes of Minnesota, of any lands needed for the construction and maintenance of said bridge, and the approaches thereto.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 307.

AN ACT ENTITLED AN ACT TO AUTHORIZE THE VILLAGE OF WATERTOWN, CARVER COUNTY, MINNESOTA, TO SUBSCRIBE, PAY FOR AND RECEIVE THE STOCK OF THE WATERTOWN MILL ASSOCIATION TO AID SAID ASSOCIATION.

Be it enacted by the Legislature of the State of Minnesota.

SECTION 1. The village council of the village of Watertown, in the county of Carver, is hereby authorized to subscribe for, receive and

pay for the stock of the Watertown Mill Association, in the sum of two thousand (2,000) dollars, or so much thereof as may be necessary to aid said Mill Association, with any money in the treasury of said village not otherwise appropriated, upon the following conditions to wit:

SEC. 2. Before any money shall be used or appropriated by the village council for the purposes specified in section one (1) of this act, there shall be submitted to the legal voters of said village, at any general or special election, at which legal notice thereof shall be given as provided by the charter of said village, the question; shall the village council appropriate of the funds of said village of Watertown, to aid the Watertown Mill Association, which said notice shall specify the amount in which said village council shall intend to extend such aid. Those voting in favor of authorizing the village council to appropriate the funds of said village for such purpose, shall have written or printed or partly written or printed thereon, "In favor of appropriating the funds of the village to aid the Watertown Mill Association," those voting against authorizing the village council to appropriate the funds of said village for such purpose, shall have written or printed or partly written or printed thereon, "Against appropriating the funds of the village to aid the Watertown Mill Association."

SEC. 3. If a majority of the legal voters of said village voting at such election, shall vote in favor of such appropriation, said village council may use and appropriate said sum of two thousand (2,000) dollars, or so much thereof as may have been authorized by the legal voters at such election, for the purposes and in the manner specified in section one of this act.

SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER 308.

AN ACT TO AUTHORIZE THE BOARD OF COUNTY COMMISSIONERS OF BLUE EARTH COUNTY TO PAY THE LICENSE MONEY COLLECTED FROM THE SALES OF INTOXICATING LIQUORS IN THE VILLAGE OF HILTON TO THE TREASURER OF SCHOOL DISTRICT NUMBER ONE HUNDRED AND FORTY SIX (146) SAID COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That all moneys collected from the sale of intoxicating liquors in the village of Hilton in Blue Earth county shall be paid into the county treasury of said county for the sole use and benefit of
