

pay for the stock of the Watertown Mill Association, in the sum of two thousand (2,000) dollars, or so much thereof as may be necessary to aid said Mill Association, with any money in the treasury of said village not otherwise appropriated, upon the following conditions to wit:

SEC. 2. Before any money shall be used or appropriated by the village council for the purposes specified in section one (1) of this act, there shall be submitted to the legal voters of said village, at any general or special election, at which legal notice thereof shall be given as provided by the charter of said village, the question; shall the village council appropriate of the funds of said village of Watertown, to aid the Watertown Mill Association, which said notice shall specify the amount in which said village council shall intend to extend such aid. Those voting in favor of authorizing the village council to appropriate the funds of said village for such purpose, shall have written or printed or partly written or printed thereon, "In favor of appropriating the funds of the village to aid the Watertown Mill Association," those voting against authorizing the village council to appropriate the funds of said village for such purpose, shall have written or printed or partly written or printed thereon, "Against appropriating the funds of the village to aid the Watertown Mill Association."

SEC. 3. If a majority of the legal voters of said village voting at such election, shall vote in favor of such appropriation, said village council may use and appropriate said sum of two thousand (2,000) dollars, or so much thereof as may have been authorized by the legal voters at such election, for the purposes and in the manner specified in section one of this act.

SEC. 4. This act shall take effect and be in force from and after its passage.

## CHAPTER 308.

[H. F. No. 238.]

AN ACT TO AUTHORIZE THE BOARD OF COUNTY COMMISSIONERS OF BLUE EARTH COUNTY TO PAY THE LICENSE MONEY COLLECTED FROM THE SALES OF INTOXICATING LIQUORS IN THE VILLAGE OF HILTON TO THE TREASURER OF SCHOOL DISTRICT NUMBER ONE HUNDRED AND FORTY SIX (146) SAID COUNTY.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That all moneys collected from the sale of intoxicating liquors in the village of Hilton in Blue Earth county shall be paid into the county treasury of said county for the sole use and benefit of

school district number one hundred and forty-six (146) in said Blue Earth county.

SEC. 2. It shall be the duty of the county treasurer of said county of Blue Earth to pay over to the treasurer of school district number one hundred and forty-six (146) in said county all moneys collected as license money in the village of Hilton, said county, in the same manner as other school funds are now paid to the several school districts.

SEC. 3. All acts and parts of acts inconsistent with the provisions of this act be and the same are hereby repealed.

SEC. 4. This act shall take effect and be in force from and after its passage.

## CHAPTER 309.

[H. F. No. 237.]

AN ACT TO AUTHORIZE THE BOARD OF COUNTY COMMISSIONERS OF BLUE EARTH COUNTY TO PAY THE LICENSE MONEY COLLECTED FROM THE SALES OF INTOXICATING LIQUORS IN THE VILLAGE OF GOOD THUNDER TO THE TREASURER OF SCHOOL DISTRICT NUMBER EIGHTY-SEVEN (87), SAID COUNTY.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION. 1. That all moneys collected from the sale of intoxicating liquors in the village of Good Thunder in Blue Earth county, shall be paid into the county treasury of said county, for the sole use and benefit of school district number eighty-seven (87) in said Blue Earth county.

SEC. 2. It shall be the duty of the county treasurer of said county of Blue Earth to pay over to the treasurer of school district number eighty-seven (87) in said county, all moneys collected as license money in the village of Good Thunder, in said county, in the same manner as other school funds are now paid to the several school districts.

SEC. 3. All acts and parts of acts inconsistent with the provisions of this act be and the same are hereby repealed.

SEC. 4. This act shall take effect and be in force from and after its passage.
