and subscribe an oath faithfully to perform the duties of his office, which oath shall be endorsed on the appointment and recorded in the office of the register of deeds. Said register of deeds shall be responsible for the acts of his deputies, and may revoke their appointments at pleasure.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 333.

AN ACT TO AUTHORIZE THE COMMISSIONERS APPOINTED AND OR-GANIZED UNDER CHAPTER THREE HUNDRED AND SEVENTY-SIX (376) OF THE SPECIAL LAWS OF THE STATE OF MINNESOTA FOR THE YEAR A. D., ONE THOUSAND EIGHT HUNDRED AND EIGHTY-ONE (1881) IN RELATION TO THE ERECTION OF PUBLIC BUILD-INGS FOR THE USE OF THE CITY OF SAINT PAUL AND COUNTY OF RAMSEY, AND THE ACTS AMENDATORY THEREOF AND SUP-PLEMENTARY THERETO, TO EMPLOY A SUPERINTENDENT OF THE WORK REQUIRED AND CONTEMPLATED IN SAID ACTS, AND PRO-VIDING FOR HIS COMPENSATION, AND COMPENSATION FOR SER-VICES IN SUCH SUPERINTENDENCE HERETOFORE RENDERED.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the special commissioners appointed and organized under and pursuant to an act of the legislature of the state of Minnesota entitled, "An act in relation to the erection of public buildings for the use of the city of Saint Paul and the county of Ramsey, upon block twenty (20) of Saint Paul proper, known as the Court House Square, in said city of Saint Paul," approved March eighth (8th), one thousand eight hundred and eighty-one (1881), and who since said appointment and organization have been engaged in the erection of said building contemplated in said act, on said block twenty (20), and in the performance of the duties devolved upon them in said act and the further acts of said legislature amendatory thereof and supplementary thereto, for the purpose of the better completion of said building and furnishing the same ready for occupancy, and the grading and ornamentation of said grounds as provided and contemplated in said several acts, are hereby authorized to employ in addition to the architect, one superintendent of said work, who may be selected from their own number, as in teir udgment may be best, and whose duties shall be directed and term of services determined by said commissioners, not exceeding a period necessary for the completion and furnishing of the building and the

completion of the grounds in said court house square, and whose compensation shall be fixed and allowed by said commissioners, and paid out of the court house and city hall building fund provided in said acts on such allowance; and said commissioners are further authorized to fix and allow such compensation as in their judgment may be reasonable and just for the services of said superintendent heretofore rendered at their request or by their appointment, and the compensation for such past services so fixed and allowed, shall be in like manner paid out of said building fund.

SEC. 2. All parts of said acts or of either or any of them inconsistent with the provisions of this act, are hereby repealed.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 334.

[H. F. No. 423.]

AN ACT TO AUTHORIZE THE CLERK OF THE DISTRICT COURT OF C RAMSEY COUNTY TO TRANSCRIBE CERTAIN RECORDS IN HIS OF-FICE.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the clerk of the district court of the county of Ramsey in said state, is hereby authorized at the expense of said county to procure suitable books for transcribing the docket entries of all judgments docketed in said court and now remaining in full force and unsatisfied.

Said clerk shall, as soon as practicable, transcribe said judgment docket entries into books so procured as aforesaid and when so transcribed, the transcribed record shall have the same force and effect whether as evidence or otherwise, as the original record thereof.

SEC. 2. The said clerk shall at the expense of said county of Ramsey, procure such standard index books as are used for like purpose in Hennepin county, said state, for the purpose of transcribing the indexes of actions and proceedings and of the records of marriage license and naturalization papers and such other records as the judges of said court may deem proper.

SEC. 3. That as compensation for services as required in this act said clerk shall receive:

For transcribing entries of judgment docket for each judgment debtor, five (5) cents.

For indexes of actions and proceedings, two (2) cents for each name indexed.
