CHAPTER 507.

AN ACT TO ATTACH SECTIONS FOUR (4), FIVE (5), AND SIX (6), IN TOWN ONE HUNDRED AND TWENTY-SIX (126), RANGE FORTY-SIX (46), TO SCHOOL DISTRICT NUMBER FORTY-FIVE (45), IN TRAVERSE COUNTY, MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. Sections four (4), five (5), and six (6), in township one hundred and twenty-six (126), range forty-six (46), are attached to school district number forty-five (45), in Traverse county, Minnesota, and for all school purposes do become a part of said district.

SEC. 2. All acts or parts of acts inconsistent herewith are hereby repealed.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 508.

AN ACI' TO AMEND SECTION ONE [1] OF CHAPTER TWO HUNDRED AND SEVENTY-FOUR (274) OF THE SPECIAL LAWS OF 1887, ENTI-TLED "AN ACT TO CHANGE AND DEFINE THE BOUNDARIES OF THE INDEPENDENT SCHOOL DISTRICT OF LITTLE FALLS."

Be it enacted by the Legislature of the State of Minnesota.

SECTION 1 That section one (1) of chapter two hundred and seventy-four (274) of the Special Laws of 1887, entitled, "An act to change and define the boundaries of the independent school district of Little Falls, be and the same is hereby amended, so as to read as follows:

Falls, be and the same is hereby amended, so as to read as follows: That the independent school district of Little Falls heretofore created by chapter one hundred and twenty-six (126) of the special laws of eighteen hundred and seventy-nine (1879) shall hereafter consist of the following described territory situated within the county of Morrison, to wit: All of sections twenty-five (25), twenty-six (26), twenty-seven (27), thirty-four (34), thirty-five (35), thirty-six (36), in township forty-one (41) of range thirty-two (32), and all of sections seven (7), eight (8), nine (9), sixteen (16), seventeen (17) and eighteen (18); the west half of section ten (10), the rorth half of section twenty (20), and the north half of section twenty-one (21), in township forty (40), of range thirty-two (32), and all of sections seventeen (17), eighteen (18), nineteen (19), and thirty (30), in township one hundred and twenty-nine (129) of range twenty-nine (29), are hereby declared and established and shall hereafter constitute and be known as The Independent School District of Little Falls.

SEC. 2. That all acts and parts of acts inconsistent with this act are hereby repealed.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 509.

AN ACT TO DETACH CERTAIN LANDS FROM THE CLEARWATER INDEPENDENT SCHOOL DISTRICT.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That sections nineteen (19), twenty (20), twenty-nine (29), and thirty (30), township one hundred and twenty-three (123) north of range twenty-seven (27) west, in town of Lynden, Stearns county, Minnesota, be and the same is hereby detached from the Clearwater independent school district. *Provided*, said described premises shall be and remain a part of said Clearwater independent school district for school purposes and be taxed therein for its support until such time as said lands, or the same together with other territory, shall be organized by the county commissioners of Stearns county into a new school district.

SEC. 2. This act shall take effect and be in force from and after its passage.
