AN ACT TO INVEST THE COMMON SCHOOL DISTRICT NO. SIXTY-FOUR (64) IN SIBLEY COUNTY, MINNESOTA, WITH THE RIGHT TO ONE-FOURTH (1/2) OF ALL MONEY PAID INTO THE VILLAGE TREASURY OF THE VILLAGE OF GIBBON IN SAID COUNTY OF SIBLEY ON ACCOUNT OF ANY LIQUOR LICENSE OR LICENSES, AND TO PRO. VIDE FOR THE PAYMENT OF THE SAME INTO THE TREASURY OF THE SAID SCHOOL DISTRICT.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. Common school district number sixty-four (64) in Sibley county, Minnesota, is hereby invested with the right and title to one-fourth $(\frac{1}{4})$ of all moneys which shall after the passage of this act be paid into the village treasury of the village of Gibbon in Sibley county on account of any liquor license or licenses.

SEC. 2. Upon the payment into the treasury of said village after the passage of this act on account of any liquor license or licenses the treasurer of said village shall forthwith set apart one-fourth $(\frac{1}{4})$ of the same for the use of the said school district which he shall debit to himself in an account with the said school district, and which he shall hold in trust for said district until paid over to the treasurer of the said school district, as hereinafter provided.

SEC. 3. On the first (1st) Monday in October in each and every year the treasurer of said village shall render to the trustees of said school district a true and complete and itemized account of all moneys paid to him on account of any liquor license or licenses during the year then last past except that the account rendered in October one thousand eight hundred and eighty-nine (1889) shall only contain sums paid from and after the passage of this act, and thereupon the one-fourth $(\frac{1}{4})$ of all sums paid to said treasurer of said village during the period covered by the said account on account of any liquor license or licenses shall be due and payable by the said treasurer of the village to the said common school district, and the treasurer of said village shall pay the same to the treasurer of said school district upon the order of the said trustees.

SEC. 4. In his account with the said village said treasurer of said village shall be credited with all sums by him paid pursuant to this act.

SEC. 5. All moneys paid to the treasurer of said school district pursuant to this act, shall be by him debited to himself in his account with said school district and shall be disbursed in like manner and for like purposes as provided by law for the disbursements of the current school fund, apportioned to said school district.

SEC. 6. All acts and parts of acts inconsistent with this act are hereby repealed.

SEC. 7. This act shall take effect and be in force from and after its passage.
