CHAPTER 541.

AN ACT TO REPEAL AN ACT ENTITLED "AN AUT TO AUTHORIZE THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY, MINNESOTA. TO LEVY A TAX FOR BUILDING AND FURNISHING A NEW COURT HOUSE" APPROVED FEBRUARY SECOND (2nd), ONE THOUSAND EIGHT HUNDRED AND EIGHTY-SEVEN (1887).

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That chapter two hundred and forty-seven (247) of the special taws of Minnesota for the year one thousand eight hundred and eighty-seven (1887), entitled "an act to authorize the board of county commissioners of Douglas county, Minnesota, to levy a tax for building and furnishing a new court house, approved February second (2d), one thousand eight hundred and eighty-seven (1887), be and the same is hereby repealed.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 542.

AN ACT TO REPEAL SECTION ELEVEN (11) OF CHAPTER EIGHTY-FIVE (85) OF THE SPECIAL LAWS OF ONE THOUSAND EIGHT HUN-DBED AND EIGHTY-SEVEN (1837), ENTITLED "AN ACT TO AMEND AN ACT ENTITLED 'AN ACT FOR THE ESTABLISHMENT AND REG-ULATION OF THE PUBLIC SCHOOLS IN THE CITY OF WINONA', AP-PROVED MARCH SIXTH (6TH), ONE THOUSAND AND EIGHT HUND-RED AND SEVENTY-EIGHT (1878), AND BEING CHAPTER ONE HUNDRED AND FIFTY-FIVE (155) OF THE SPECIAL LAWS OF THAT YEAR, AND SEVERAL ACTS AMENDATORY THEREOF."

Be it enacted by the Legislature of the State of Minnesota;

SECTION 1. That section eleven (11) of chapter eighty-five (85) of the special laws of one thousand eight hundred and eighty-seven (1887), approved February twelfth (12th), eighteen hundred and eighty-seven (1887), and entitled "An act to amend an act entitled 'An act for the establishment and regulation of the public schools in the city of Winona,' approved March sixth (6th), one thousand and eight hundred and seventy-eight (1878), and being chapter one hundred and fifty-five (155) of the special laws of that year, and several acts amendatory thereof," be and the same is hereby repealed.

SEC. 2. This act shall take effect and be in force from and after its passage.
