

CHAPTER 562.

AN ACT TO LEGALIZE THE ORGANIZATION OF THE POPE COUNTY AGRICULTURAL ASSOCIATION; TO AUTHORIZE IT TO OWN AND TRANSFER REAL ESTATE; TO LEGALIZE ITS ACTS AND CONTRACTS RELATING TO REAL ESTATE, AND TO PRESCRIBE HOW CONTRACTS, DEEDS, ETC., BY IT SHALL BE EXECUTED.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the organization of the association known as the Pope County Agricultural Association, organized in the county of Pope in this state be and the same is hereby in all things legalized and confirmed, and the said association is hereby authorized and empowered to buy, own, mortgage, transfer and sell real estate for the purposes of said association, and that all acts and contracts heretofore entered into by said association pertaining to the purchase, sale or mortgaging real estate be and the same is hereby legalized and confirmed.

SEC. 2. That all contracts, deeds and mortgages given by said association shall be executed by the president and secretary of the association upon their being duly authorized by a majority of those present at any meeting of said association, and need not be under seal of the association.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 563.

AN ACT ENTITLED AN ACT LEGALIZING CERTAIN CLAIMS AGAINST THE CITY OF MINNEAPOLIS, AND AUTHORIZING THE PAYMENT OF THE SAME.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. Whereas during the year one thousand eight hundred and eighty-seven (1887), W. J. Bowen, Charles Filteau, and the firm of Roach & Wilson, done and performed labor and services for the use and benefit of the city of Minneapolis, in grading certain streets in the said city, which grading was done under the direction and supervision of the city engineer of said city, and which grading was accepted by the said city, and is used by the said city, and the city council of the said city determined the amounts due to each of the said

parties for the work so done as aforesaid to be the following amounts: To W. J. Bowen, the sum of eleven thousand three hundred and twenty-five dollars and fifty cents (\$11,325.50); to Charles Filteau, seven thousand one hundred and fourteen dollars and fifty-one cents (\$7,114.51), and to Roach & Wilson, two thousand and one dollar and seventy cents (\$2,001.70):

And by resolution of the city council of the said city duly adopted on the tenth (10th) day of August, one thousand eight hundred and eighty-eight (1888), the said city council ordered the aforesaid amounts to be paid to the said parties so entitled thereto:

NOW THEREFORE, be it enacted:

SEC. 2. That the city council of the city of Minneapolis, be, and are, hereby authorized and empowered to pay to W. J. Bowen, the sum of eleven thousand three hundred and twenty-five dollars and fifty cents (\$11,325.50); To Charles Filteau, the sum of seven thousand one hundred and fourteen dollars and fifty-one cents (\$7,114.51), and to Roach & Wilson, the sum of two thousand and one dollar and seventy cents (\$2,001.70), for their claims for work by them so done as aforesaid, with interest thereon at the rate of seven (7) per cent. per annum from and since the tenth (10th) day of August, A. D., one thousand eight hundred and eighty-eight (1888).

SEC. 3. The city council of the said city of Minneapolis are hereby authorized and empowered to order payment of the said several amounts as set forth in section two (2) of this act.

The city clerk of the said city of Minneapolis is hereby authorized and empowered, upon being thereto directed by the said city council, to draw orders in favor of the said W. J. Bowen, Charles Filteau and Roach & Wilson for the said several amounts mentioned and set forth in section two (2) of this act.

And the mayor of the said city of Minneapolis is hereby authorized and empowered to sign the said orders so drawn by the city clerk.

And the comptroller of the said city of Minneapolis is hereby authorized and empowered to countersign the said orders so drawn by the said city clerk.

And the city treasurer of the said city of Minneapolis is hereby authorized and empowered to pay the said orders so drawn by the said city clerk in favor of the said W. J. Bowen, Charles Filteau and Roach & Wilson for the several amounts mentioned in section two (2) of this act, out of the moneys in the city treasury of the said city of Minneapolis belonging to the street improvement fund of the eighth (8th) ward of said city of Minneapolis, not otherwise appropriated, with interest thereon at the rate of seven (7) per cent per annum from August tenth (10th), eighteen hundred and eighty-eight (1888.)

SEC. 4. This act shall be in force and take effect from and after its passage.
