Pacific railroad company, be and the same is hereby confirmed and legalized and shall be valid and effectual for all purposes therein named.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 570.

AN ACT TO LEGALIZE THE INCORPORATION AND ORGANIZATION OF THE VILLAGE OF STEWART IN McLEOD COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the proceedings for the incorporation and organization of the village of Stewart in McLeod county in this state be and the same are hereby legalized and the said village of Stewart is hereby declared to be fully and legally incorporated and organized as fully and to all intents and purposes as if all the legal steps had been properly taken to incorporate and organize said village and all acts and proceedings heretofore had and taken by the officers of said village are hereby declared to be legal and of full force and effect.

Sec. 2. This act shall take effect and be in force from and after its

passage.

CHAPTER 571.

AN ACT TO LEGALIZE THE INCORPORATION OF THE MONTE-FIORE ASSOCIATION AND DECLARING THE SAME TO BE A LEGAL CEMETERY ASSOCIATION.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the incorporation of the Montefiore association, a cemetery association located in the city of Minneapolis, Minnesota, is hereby legalized and declared valid, notwithstanding any omission or defect in the attempt to incorporate the same, and such omissions

and defects are hereby cured, and said corporation made a valid and legal cemetery association under and pursuant to the general laws of the state of Minnesota relating to cemetery associations.

SEC. 2. This act shall take effect and be in force from and after

its passage.

CHAPTER 572.

[H. F. No. 1061.]

AN ACT TO LEGALIZE THE ORGANIZATION OF CERTAIN TOWNS AND SCHOOL DISTRICTS IN PINE COUNTY AND TO LEGALIZE THE OFFICIAL ACTS OF THE OFFICERS OF SAID TOWNS AND SCHOOL DISTRICTS.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That the organization of the following named towns in the county of Pine, state of Minnesota, to-wit: Windemer, Kettle River, Hinckley, Mission Creek, Pine City, Rock Creek, Royalton and Chengwatana be and the same is hereby legalized and made valid to

all intents and purposes.

SEC. 2. That the organization of the following named common school districts in the county of Pine, to-wit: school districts numbered one (1), two (2), three (3), four (4), five (5), six (6), seven (7), eight (8), nine (9), ten (10), eleven (11), twelve (12), thirteen (13), fourteen (14), fifteen (15), sixteen (16) and seventeen (17) be and the same is hereby legalized and made valid to all intents and purposes.

SEC. 3. That all of the acts and proceedings of the board of county commissioners of said county of Pine in organizing said towns and school districts as the same are now organized and all of the official acts of the officers of said towns and school districts are hereby legal-

ized and declared valid.

SEC. 4. This act shall take effect and be in force from and after its passage.
