

CHAPTER 78.

[H. F. No. 717.]

AN ACT TO AMEND AN ACT ENTITLED AN ACT TO INCORPORATE
THE CITY OF WEST ST. PAUL.*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. Section two (2) of chapter one (1) is hereby amended so as to include the southwest quarter (sw $\frac{1}{4}$) of southeast quarter (se $\frac{1}{4}$) of section seven (sec. 7) in addition to the territory therein described as constituting the limits and boundaries of said city of West St. Paul.

SEC. 2. That section five (5) of chapter five (5) is hereby amended by striking out the word "subsequent" in the third (3d) line of said section and placing in lieu therefor the word "prior."

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 79.

AN ACT TO AMEND CHAPTER EIGHTEEN (18) OF THE SPECIAL
LAWS OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-
SEVEN (1877), ENTITLED, "AN ACT TO AMEND AND REVISE CHAP-
TER NINE (9) OF THE SPECIAL LAWS OF ONE THOUSAND EIGHT
HUNDRED AND SEVENTY (1870), INCORPORATING THE VILLAGE
OF EAST JANESVILLE, AND THE ACTS AMMENDATORY THEREOF."*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That section fifteen (15) of chapter eighteen (18) of the special laws of one thousand eight hundred and seventy-seven (1877), be and the same is hereby amended, by adding thereto another subdivision, to be called the thirty-first, to-wit:

Section 31. To prescribe the limits in which wooden buildings, smoke-houses, ovens, and other structures whose material, construction or use shall be dangerous, on account of fire, to the surrounding property, shall not be hereafter erected, placed or repaired; to provide that all or any buildings within such limits shall hereafter be built and constructed in such manner, and of such materials, as will not be dangerous, on account of fire to surrounding property; to provide that smoke-houses or ovens already built within such limits be removed; and to prohibit the repairing or rebuilding of wooden build-

ings within such limits, when the cost of such repairs or rebuilding, shall be equal in value to the building so repaired and rebuilt.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 80.

AN ACT TO AMEND SECTION SIXTEEN (16) OF CHAPTER NINE (9) OF CHAPTER FIVE (5) OF THE SPECIAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND EIGHTY-SEVEN (1887) ENTITLED AN ACT TO AMEND THE CHARTER OF THE CITY OF WINONA.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. Section sixteen (16) of chapter nine (9) of chapter five (5) of the special laws of one thousand eight hundred and eighty-seven (1887), is hereby amended so as to read as follows:

"Section 16. Said city shall be liable in all cases for the board, washing and fees on commitment of all persons committed to the jail of Winona county by the municipal court."

SEC. 2. This act shall take effect and be in force from and after its passage.
