

Lac qui Parle
county.

In the county of Lac qui Parle, on the first (1st) Tuesday in May and the fourth (4th) Tuesday in October of each year.

Kandiyohi
county.

In the county of Kandiyohi, on the first (1st) Tuesday in June and the second (2d) Tuesday in December of each year.

Meeker county.

In the county of Meeker, on the third (3d) Tuesday in May and the second (2d) Tuesday in November of each year.

Swift county.

In the county of Swift, on the fourth (4th) Tuesday in June and the third (3d) Tuesday in December of each year.

Yellow Medi-
cine county

In the county of Yellow Medicine, on the third (3d) Tuesday in June and the second (2d) Tuesday in January of each year.

SEC. 2. All writs, process, orders, continuances, appeals, bonds, recognizances, notices and proceedings issued, made or returnable to the general terms of court in and for said counties respectively, as prescribed by law prior to the passage of this act, shall be deemed and construed as made, taken and returnable to the proper term of said court, in the said counties respectively, as prescribed in this act.

SEC. 3. All acts and parts of acts inconsistent with this act are hereby repealed.

SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER 141.

Fourteenth ju-

AN ACT TO FIX THE TIMES FOR HOLDING THE GENERAL TERMS OF DISTRICT COURT IN AND FOR NORMAN COUNTY, IN THE FOURTEENTH (14TH) JUDICIAL DISTRICT, MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota:

Terms of court.

SECTION 1. That the general term of the district court in and for the county of Norman, Fourteenth (14th) judicial district of the state of Minnesota, shall be held in each year on the first (1st) Wednesday after the first (1st) Monday of November; *Provided*, That the judge of said court and county commissioners of said county may, by order made and filed with the clerk of said court at least forty (40) days prior to the first (1st) Monday of May in each year, convene said court in general term on said first (1st) Monday of May in each year.

Norman county.

SEC. 2. All writs, processes, bonds, recognizances, continuances, appeals, notices and proceedings had, issued or returnable to the terms of court in and for said county of Norman, as fixed by law prior to the passage of this act, shall be deemed and construed as made, taken and returnable to the terms of court as fixed by this act.

SEC. 3. All acts and parts of acts inconsistent herewith are hereby repealed.

SEC. 4. This act shall take effect from and after the first (1st) day of June, one thousand eight hundred and ninety-one (1891).

CHAPTER 142.

AN ACT FIXING THE TIME FOR HOLDING THE GENERAL TERMS OF THE DISTRICT COURT IN THE FOURTEENTH (14TH) JUDICIAL DISTRICT. Fourteenth judicial district.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The general terms of the district court of the Fourteenth (14th) judicial district of the state of Minnesota shall be held as follows: Terms of court.

In the county of Becker, on the fourth (4th) Monday in January and the first (1st) Monday after the fourth (4th) day of July in each year. Becker county.

In the county of Clay, on the first (1st) Tuesday after the first (1st) day of January and the third (3d) Monday in June in each year. Clay county.

In the county of Kittson, on the fourth (4th) Monday in March in each year. Kittson county.

In the county of Marshall, on the second (2d) Monday in May and the third (3d) Monday in November in each year. Marshall county.

In the county of Norman, on the first (1st) Monday in November in odd-numbered years, and first (1st) Wednesday after first (1st) Monday of November in even-numbered years, in each year; *Provided*, That there shall be held in said county a general term of said court on the first (1st) Monday of May in the year A. D. one thousand eight hundred and ninety-one (1891); and that the judge of said court and the county commissioners of said county may, by order made and filed with the clerk of said court at least forty (40) days prior to the first (1st) Monday of May in any year, convene said court in general term on the first (1st) Monday of May in any year.
