During the fiscal year the bonded indebtedness of the state has been reduced as follows: Revenue bond, No. 1, \$50,000, issued under law of 1889,—paid from redemption fund.

The funding commission, created by "Chapter 31, General Laws, 1891," redeemed \$95,000 of the funding bonds of 1891, held by the permanent university fund, by transferring land contracts amounting to \$86,763.48, and cash \$8,236.52 from the internal improvement land (sinking) fund to the permanent university fund.
