*An act to repeal chapter ninety-four (94) of the Special Laws of the State of Minnesota for the year one thousand eight hundred and eighty-five (1885), entitled, "An act to amend chapter three hundred and ten (310) of the Special Laws of the year one thousand eight hundred and eighty-three (1883), entitled, 'An act in relation to the abstract clerk of Ramsey county,' approved February twenty-seventh, one thousand eight hundred and eighty-three (1883)," which said act was approved March 5th, 1885.*

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That chapter ninety-four (94) of the Special Laws of the State of Minnesota for the year one thousand eight hundred and eighty-five (1885), entitled, "An act to amend chapter three hundred and ten (310) of the Special Laws of the year one thousand eight hundred and eighty-three (1883), entitled, 'An act in relation to the abstract clerk of Ramsey county,' approved February twenty-seventh, one thousand eight hundred and eighty-three (1883)," which said act was approved March 5th, 1885, be and the same is hereby repealed.

SEC. 2. This act shall take effect and be in force from and after the first Monday in January in the year one thousand nine hundred and one (1901).

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That chapter four hundred and forty-three (443) of the Special Laws of one thousand eight hundred and ninety-one (1891), entitled, "An act to fix the salary of county officers for Renville county, and authorizing the commissioners of said county to provide clerks for certain offices and that certain fees collected be paid into the county treasury," be and the same is hereby repealed.

SEC. 2. This act shall take effect and be in force from and after its passage.
