An Act repealing chapter one hundred and ninety-eight (198) of Special Laws of 1885, relating to clerk hire of county auditor of Dodge county.

Be it enacted by the Legislature of the State of Minnesota:

Chap. 198, S. L. 1885 repealed.—Section 1. That chapter one hundred and ninety-eight (198) of the Special Laws of 1885, granting the county auditor of Dodge county certain clerk hire, be and the same is hereby repealed.

CHAPTER 128-H. F. No. 579.

An Act to amend section 1589 of the Revised Laws, 1905, relating to reports of public examiner.

Be it enacted by the Legislature of the State of Minnesota:

Public examiner to report biennially—report to be printed.—Section 1. That section 1589 of the Revised Laws, 1905, be and the same hereby is amended to read as follows:

Sec. 1589. The examiner shall report to the governor biennially touching all his official acts, giving abstracts of the statistics and condition of the various offices, institutions and corporations to which his duties relate, and making such recommendations as he may deem proper, which report shall be printed and included in the volume of executive documents.

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 129-H. F. No. 776.

An Act to amend section 1850 of the Revised Laws of 1905, relating to soldiers, when buried by the state.

Be it enacted by the Legislature of the State of Minnesota:

County boards to provide for burial of soldiers and sailors.—Section 1. That section 1850 of the Revised Laws of

1905 be and the same is hereby amended so as to read as follows:

"Section 1850. Soldiers, When Buried by the State-Each county board shall cause to be decently buried, at a cost to the state of not more than fifty dollars, the body of any soldier, sailor or marine who served the United States as such in the Civil or Spanish-American war, and of any person not a soldier who actually served in this state in the Indian war of 1862, and who dies within the county or is brought thereto for interment, and has not left sufficient means to defray the expenses of suitable burial. Such interment shall not be made in any place used exclusively for the burial of the pauper dead, and the relatives or comrades of the deceased, if they so desire, shall be permitted to conduct the burial services."

An Act entitled " An act providing for the issuance of inter- 1907 C 13 est-bearing certificates of indebtedness to aid in the erection, con-1026 n struction and furnishing of a court house, county jail and other county buildings, or either or any of them, in counties in this state 17 having property of an assessed valuation of not less than \$100,-000,000, and having a bonded indebtedness of not more than \$700,000."

Be it enacted by the Legislature of the State of Minnesota:

County board to issue bonds to complete county buildings.—Section 1. That the board of county commissioners of any county in this state having property therein of an assessed valuation of not less than \$100,000,000, and having a bonded indebtedness of not more than \$7,000,000, is hereby authorized and empowered to borrow moneys sufficient in their judgment to complete, erect and furnish a court house, jail and other county buildings previously duly authorized, such sums of money not exceeding \$600,000 as may be sufficient in their judgment, in addition to other moneys available for that purpose to so complete, erect and furnish such building or buildings, or any smaller sum, and for such purpose to issue interest-bearing certificates of indebtedness of said county pursuant to the provisions of this act.
