Sec. 2. All acts or parts of acts inconsistent with this act are hereby repealed.

Sec. 3. This act shall take effect and be in force from and after its passage.

#### CHAPTER 144—S. F. No. 260.

*An Act to authorize the sale of certain land owned by the State of Minnesota, and with the moneys arising therefrom, together with the money received from the condemnation and taking for railroad purposes of certain other land, to purchase other lands for the use of the St. Peter state hospital for insane.*

Be it enacted by the Legislature of the State of Minnesota:

**Board of control to sell land.**—Section 1. The state board of control is hereby authorized to sell the following described real estate situated in the county of Le Sueur and State of Minnesota, to-wit: So much of government lot five (5) in section No. fifteen (15), in township No. one hundred and ten (110) north, of range No. twenty-six (26) west, as lies west of a straight line extending southwesterly from a point on the north boundary line of said lot, which point is five hundred and four (504) feet west of the northeast corner of said lot to a point on the south boundary line of said lot, which point is thirteen hundred eighty-six and 45-100 (1386.45) feet west from the southeast corner of said lot; and also, so much of government lot six (6) of said section as lies west of a straight line extending southwesterly from a point on the north boundary line of said lot, which point is seventy-three and 45-100 (73.45) feet west of the northeast corner of said lot, to a point on the south boundary line of said lot, which point is nine hundred forty-five and 25-100 (945.25) feet west of the southeast corner of said lot.

**Disposition of proceeds of sale.**—Sec. 2. The moneys received from the sale of said lands, together with the moneys received on account of the condemnation and taking for railroad purpose by the Chicago, St. Paul, Minneapolis & Omaha

Railway company of so much of said lots five (5) and six (6) respectively, as lies east of the lands herein authorized to be sold shall be used to purchase other lands, for the use of the St. Peter hospital for insane.

Sec. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 145—S. F. No. 293.

*An Act authorizing the state board of control to cause surgical operations to be performed upon inmates of the state hospitals and asylums for the insane and the school for feeble-minded and colony for epileptics.*

Be it enacted by the Legislature of the State of Minnesota :

**Board of control may authorize surgical operations.—**

Section 1. That whenever in the opinion of the superintendent of a state hospital or asylum for the insane or of the school for feeble-minded and colony for epileptics a surgical operation is necessary to save the life, health, eyesight, hearing or a limb of any inmate committed thereto, he shall call in consultation some reputable physician in general practice in the city or village where such institution is situated, and if such consulting physician and superintendent shall certify to the state board of control that in their opinion such operation is necessary, as herein provided, the said superintendent shall be authorized by and with the written consent of said board and under its direction to perform or cause to be performed such surgical operations upon any such inmate as may be necessary and proper for such purpose, provided that the consent of the proper relatives or guardian cannot be had in season to effect such saving.

**Board to be deemed guardian.—**Sec. 2. The said board shall be deemed the guardian of the persons of the inmates of such institutions for the purpose of consenting to such operations.

Sec. 3. This act shall take effect and be in force from and after its passage.
