CHAPTER 211-S. F. No. 481.

An Act to amend section 2953, Revised Laws, 1905, relating to bonds of trustees of cemetery associations.

Be it enacted by the Legislature of the State of Minnesota:

Trustees to give bonds not less than \$500.—Section 1. That section 2953, Revised Laws of 1905, be and the same hereby is amended so as to read as follows:

Section 2953. Before entering upon his duties, each person chosen as a trustee of such fund shall give bond to the association in a sum not less than five hundred (500) dollars, and at least equal to one-third (1-3) the amount of the fund at that time, conditioned for the faithful discharge of his trust. Upon July 1 in each even numbered year every trustee shall give a new bond, in amount and with conditions as aforesaid. Every such bond shall be approved by a judge of the judicial district in which such cemetery or some part thereof is strate, and filed with the treasurer of the association. Failure by any trustee to renew his bond within thirty days after the time herein specified shall be a sufficient ground for his removal on application of any person interested.

Sec. 2. This act shall take effect and be in force from after its passage.

CHAPTER 212-S. F. No. 559.

An Act to amend section five thousand one hundred and thirty-four (5134) of the Revised Laws, 1905, relating to divulging felegrams and telephone messages.

he it enacted by the Legislature of the State of Minnesota:

Displaying tolegrams or telephone messages misdemination penalty. Section 1. That section five thousand one from telephone things (5134) of the Revised Laws, 1905, be and the same is likely amended so as to read as follows:

Section 5134. Divulging telegram or telephone messing. Every person who shall wrongfully obtain or attempt brain any knowledge of a telegraphic or telephonic message by connivance with a clerk, operator, messenger or other employe of a telegraph or telephonic company, and every clerk, operator, messenger or other employe who shall wilfully divulge to any but the person for whom it was intended, the contents of any telephonic message or any telegraphic message intrusted to him for transmission or delivery, or the nature thereof, or who shall wilfully refuse or neglect duly to transmit or deliver any such telegraphic message shall be punished by imprisonment in the county jail for not more than six months or by fine of not more than one thousand dollars (\$1,000), or by both.

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 213-S. F. No. 643.

An Act to amend section 5189, Revised Laws, 1905, relating to miscellaneous crimes.

Be it enacted by the Legislature of the State of Minnesota:

Fumigated barley and oats to be sold under certain restrictions.—Section 1. That section 5189, Revised Laws, 1905, be and the same is hereby amended so as to read as follows:

Any person who shall sell or offer for sale, or for shipment and sale, any barley or other grain, which shall have been subjected to fumigation, or other treatment by sulphur or other material, or to any other chemical process, affecting the color thereof, shall be guilty of a felony, and punished by a fine of not more than five hundred dollars (\$500), or by imprisonment in the state prison for not more than one year, or by both such fine and imprisonment; and shall also be liable to any person injured in treble damages; provided, that barley and oats may be purified by fumigation, or treatment with sulphur, under such restrictions, rules and regulations as the railroad and warehouse commission shall prescribe for such purpose, and when so purified may be sold and marketed as "Purified Barley" or as "Purified Oats," and not otherwise.

Sec. 2. This act shall take effect and be in force upon and after its passage.
