An Act to appropriate moncy to commemorate the services of the First Regiment of Minnesota Volunteers and their late colonel, William Colville, and to provide a suitable monument for his grave.

Be it enacted by the Legislature of the State of Minnesota:

\$10,000 appropriated for bronze figure of Col. Colville.—Section. 1. There is hereby appropriated from any money not otherwise appropriated the sum of ten thousand (\$10,000) dollars, to erect in the capitol of this state an heroic bronze figure of the late Col. William Colville in commemoration of the services of the First Regiment of Minnesota Volunteers, which he commanded in the memorable battle of Gettysburg, and also to erect a replica of such figure on a suitable granite base at the place of his burial in Cannon Falls, Minnesota.

Commission to be appointed by Governor—money, how expended.—Sec. 2. The governor of this state is hereby authorized to appoint a commission of five persons, to be selected from the survivors of said regiment, which commission shall have authority to carry out the provisions of this act; and the money hereby appropriated shall be disbursed on their order approved by the governor, and any sum, if any, which shall remain undisposed of shall be turned over to the general fund of the treasurer.

Sec. 3. This act shall take effect and be in force on and after its passage.

CHAPTER 71—H. F. No. 227.

An Act to amend section 5449 of the Revised Laws for the State of Minnesota, 1905, relating to the employment of prisoners confined in the state prison and state reformatory.

Be it enacted by the Legislature of the State of Minnesota:

Prisoners, how employed—commission to determine—binding twine plant, brush factory and machinery factory except.—Section 1. That section 5449 of the Revised Laws

of the State of Minnesota for 1905 be amended so as to have said section read as follows:

"Section 5449. The number of prisoners employed in a single industry at the same time, at any institution coming under the provisions of this act, shall not exceed 10 per cent of the total number of men engaged in such industry in this state unless a greater number is necessary to produce material or articles to be supplied to state and other municipal institutions, penal or charitable. The number employed in any such industry shall be determined by a commission of three (3) to consist of the labor commissioner, who shall be chairman, a member of the board of control, and a citizen of the state engaged or interested in some manufacturing industry, not connected with the state prison, or reformatory; the last two to be appointed by the governor.

Provided, however, that this section shall not apply to the number of prisoners employed in the manufacture of binding twine in the state prison at Stillwater, nor shall it apply to the number of prisoners employed in the manufacture of brushes at the state reformatory now at St. Cloud, nor shall it apply to the number of prisoners hereafter employed in the manufacture of binders, mowers and rakes at the state prison at Stillwater, nor shall it apply to the number of prisoners hereafter employed at the state prison at Stillwater in any industry not now carried on in this state, and which may be hereafter inaugurated at said state prison.

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 72-H. F. No. 755.

An Act to legalize certain proceedings heretofore taken for the drainage of lands in certain cases.

Be it enacted by the Legislature of the State of Minnesota.

Legalizing proceedings for drainage.—Section 1. Where the county commissioners of any county in this state, in pursuance of chapter 258 of the General Laws of 1901, as amended, or in pursuance of chapter 230 of the General Laws of 1905, have located, established and constructed or
