

## CHAPTER 83—H. F. No. 926.

*An Act to fix the salary of the judge of probate in counties exceeding twenty-seven thousand (27,000) population, wherein the salary of the judge of probate is arbitrarily fixed at twelve hundred (1,200) dollars or less per annum, and where there are no provisions for probate clerk hire.*

Be it enacted by the Legislature of the State of Minnesota:

**Salary of judge of probate increased.**—Section 1. That in any county in the state having a population of not less than twenty-seven thousand (27,000) inhabitants wherein the salary of the judge of probate is arbitrarily fixed at twelve hundred (1,200) dollars or less per annum, and where there are no provisions for clerk hire in the probate court of said county, the salary of the judge of probate is hereby fixed at fifteen hundred (1,500) dollars per annum.

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 84—H. F. No. 939.

*An Act to amend section 31 of chapter 338, of the General Laws of Minnesota, for the year 1905, so that the money therein appropriated to aid in constructing a bridge across Bear river in the county of Fillmore, may be used to aid in constructing a bridge across Deer creek.*

Be it enacted by the Legislature of the State of Minnesota:

**Appropriation for bridge in Fillmore county.**—Section 1. That section 31, chapter 338, of the General Laws of Minnesota for the year 1905 be and the same is hereby amended so as to read as follows:

Section 31. The sum of two hundred and seventy-five (\$275) dollars to aid in constructing a bridge across Deer creek at or near the west line of section twelve (12), township one hundred three (103), north of range thirteen (13) west where the highway crosses said creek, said money to be expended under the supervision of the supervisors of the town of Spring Valley. The sum of two hundred seventy-five (275)

dollars, to aid in building a bridge across the Root river at a point in section sixteen (16), township one hundred and three (103), range nine (9), near the village of Whalen, in the town of Holt, in said county.

Said money to be expended under the supervision of the board of supervisors of said town.

The sum of two hundred and seventy-five (275) dollars, to aid in reconstructing and rebuilding the approaches of the bridge over Camp creek on the Preston and Lanesboro road in the town of Preston.

Said sum shall be expended under the supervision of a committee consisting of H. Nupson and A. D. Gray.

#### CHAPTER 85—H. F. No. 260.

*An Act to amend section 957, Revised Laws 1905, providing fees for serving notices of expiration of redemption from tax sales.*

Be it enacted by the Legislature of the State of Minnesota :

Section 1. That section 957, Revised Laws 1905, be amended to read as follows :

**Sheriffs' fees for serving notices.**—Section 957. Fees for Notice.—For serving such notice the sheriff shall receive that same fees as for the service of summons in a civil action in the district court, except that where more than one notice is served upon one person or corporation at the same time and place the sheriff shall be entitled to charge but one mileage. Such fees and the printer's fees for publishing such notice shall be paid in the first instance by the holder of the tax certificate, and repaid by the party offering to redeem such land before a certificate of redemption shall issue.
