issue to the holder and owner of the tax certificate, a special certificate, embodying the same terms and conditions, and with like force and effect, as the said original land sale certificate, and in lieu thereof.

Sec. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 115-H. F. No. 358.

An act to amend Section 608, Revised Laws 1905, relating to bonds and oath of office of county officers.

Be it enacted by the Legislature of the State of Minnesota:

Recording of bonds.—Section 1. That section 608. Revised Laws, 1905, be and the same is hereby amended so as to read as follows:

Sec. 608. Bonds recorded and forwarded to secretary of state—Official bonds of county officers when approved by the county board, and their oaths of office and the bonds and oaths of their deputies, except register of deeds, shall be filed and recorded in the office of register of deeds and when recorded shall be forwarded by such register to the secretary of state as soon as recorded. Such secretary shall submit all such bonds to the attorney general for approval as to form and execution, who, if he finds the same satisfactory, shall endorse his approval thereon and thereupon the secretary of state shall file the same in his office for the use of all parties interested.

Sec. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 116-H. F. No. 403.

An act relating to the oaths, and bonds when required, of judges and clerks of municipal courts.

Be it enacted by the Legislature of the State of Minnesota:

Oaths and bonds to be filed with secretary of state.—Section 1. The oaths, and bonds when required, after their approval. of all judges and clerks of municipal courts, whether organized under special or general law, shall hereafter be filed with the secretary of state.

They shall be in such form as the attorney general shall prescribe.

Bonds of present officers to be forwarded to secretary of state.—Sec. 2. The present several custodians of the oaths and bonds of all such officers now acting, shall, prior to May 1, 1909, forward the same to the secretary of state, who shall receipt therefor and likewise file and record the same.

## CHAPTER 117-H. F. No. 447.

An act to amend section 1158, Revised Laws 1905, relating to the service of notice upon counties and towns of the establishment of Judicial Highways.

Be it enacted by the Legislature of the State of Minnesota:

Notices; how served.—Section 1. That section 1158, Revised Laws of 1905, be amended so as to read as follows:

- 1158. Notice of Presentation—"Three Weeks' published and posted notice of the presentation of such petition shall be given in each of the counties affected, at least thirty days in advance thereof. Such notice shall contain a copy of the petition, the name of the judge to whom it will be presented, and the time and place of presentation; and proof of such notice shall be filed with the clerk before the hearing. Such notice shall also be served, in the same manner as the service of the summons in a civil action, upon each county and organized town in which, or along the boundary of which, such proposed road is sought to be established, and proof of the service of such notice on such counties and towns shall be filed with the clerk of said court before the hearing."
- Sec. 2. This act shall not affect or apply to any action or proceeding now pending in any of the courts of this state.
