

of each calendar year to what extent, if any, the whole special fund in which said proceeds of said bonds are placed and of which fund said proceeds form all or any part has been impaired or depleted by the annulment of assessments or other cause, and shall state in his annual report the amount of cash in the city treasury belonging to said fund, the amount of uncollected and unimpaired assessments due and to become due to said fund, together with the amount of said impairment or depletion of said fund, if any, the same to be itemized under the respective causes of such impairment or depletion.

In case said impairment or depletion of said fund, or any part thereof, arose by reason of any such special assessments being less than the cost of the actual improvement for which the assessment was made, it shall be the duty of the proper officer or officers of such city, and they are hereby empowered, to cause a new and additional special assessment to be made against the property which was under-assessed, so as to bring the whole assessment against said property up to the actual cost of such improvement, due regard being given to the benefits of such improvement.

This act shall not apply to any city operating under a home rule charter, framed pursuant to section 36, of article 4, of the constitution of Minnesota.

Sec. 5. This act shall take effect and be in force from and after its passage.

#### CHAPTER 403—H. F. No. 951.

*An Act prohibiting the sale and disposition of wall-eyed pike caught in certain waters of this state.*

Be it enacted by the Legislature of the State of Minnesota:

**Catching of walleyed pike prohibited in certain lakes.**—Section 1. No person shall have in possession for sale, or with intent to sell, expose or offer for sale, or sell to any person any walleyed pike caught in any lake or waters of this state which may have been heretofore or shall hereafter be stocked with walleyed pike fry of the game and fish commission of this state, at any time, or shall cause to be shipped or have in possession with intent to ship for purpose of sale to any person either within or without the state any such fish, or have any such walleyed pike in his possession except during the season for taking same.

**Violation a misdemeanor.**—Sec. 2. Any person violating the provisions of this act shall be guilty of a misdemeanor, and upon conviction shall be punished by a fine of not less than \$10.00

nor more than \$50.00 and costs of prosecution, or by imprisonment in the county jail for not less than ten days, nor more than sixty days for each offense.

Sec. 3. This act shall be in force and take effect from and after its passage.

#### CHAPTER 404—H. F. No. 996.

*An Act to prohibit any person from enticing or bringing any female person into this state for immoral purposes and to prohibit any person from inducing or procuring any female person to enter any house of ill fame, assignation or prostitution and providing a punishment for the violation thereof.*

Be it enacted by the Legislature of the State of Minnesota:

**Enticement declared unlawful.**—Section 1. It shall be unlawful for any person to induce, entice or procure, or attempt to induce, entice or procure to come into this state, any female person for the purpose of prostitution or concubinage, or for any other immoral purpose, or to induce, entice or procure any female person in this state to enter any house of ill fame, assignation or prostitution.

**Penalty for violation.**—Sec. 2. Any person who violates the provisions of this act shall, upon conviction thereof, be punished by imprisonment in the state prison for a period of not more than two years, or by a fine of not less than \$200.00 or more than two thousand dollars (\$2,000.00).

Sec. 3. This act shall take effect and be in force from and after its passage.

#### CHAPTER 405—H. F. No. 1036.

*An Act to authorize and empower the board of county commissioners of counties in this state now having or which may hereafter have a population of 275,000 or over to issue bonds and provide for the payment of such bonds, for the purpose of laying out, grading, building and improving roads and bridges in such county.*

Be it enacted by the Legislature of the State of Minnesota:

**One million dollar bond issue authorized.**—Section 1. The board of county commissioners of each and every county in this state, now having or which may hereafter have a population of
