CHAPTER 64-H. F. No. 273.

An Act to amend section 847 of Revised Laws, 1905, of the State of Minnesota, relating to employment of clerks and judges in election districts where voting machines are used.

Be it enacted by the Legislature of the State of Minnesota:

Two clerks for each voting machine.—Section 1. That section 347 of Revised Laws, 1905, of the state of Minnesota be and the same is hereby amended so as to read as follows:

Section 347. Election officers where voting machines are used.—No more than two clerks and no more than three judges shall be employed to officiate in any district wherein voting machines are used, except that in any district where two or more voting machines are used not to exceed two clerks may be employed for each voting machine used therein. The judges shall enforce the rules prescribed for the use of such machines, and carry out all the provisions of this chapter relating to the election, except such as are rendered inapplicable by the use of such machines.

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 65-H. F. No. 301.

An Act to regulate the setting of pound nets in the Mississippi River and Lake St. Croix where these waters form the boundary line between the States of Wisconsin and Minnesota.

Be it enacted by the Legislature of the State of Minnesota:

Regulation of pound nets in Mississippi river and Lake St. Croix.—Section 1. That no pound nets or string of pound nets licensed to be used or set in that part of the St. Croix river known as Lake St. Croix, that part of the Mississippi river known as Lake Pepin, and the Mississippi river, where they form the boundary line between the states of Minnesota and Wisconsin, under chapter 315, General Laws of Minnesota for 1907, shall be set less than 1,000 feet apart, and the leads of said nets or string of nets shall not extend nearer than 500 feet from the middle line of said waters.

Provided, that in part of the Mississippi river known as Lake Pepin, and in the Mississippi river from the mouth of Lak^{*} St. Croix to the southern boundary line of this state, such nets shall not be set less than one thousand feet apart, and the leads of such nets or strings of nets shall not extend nearer than five hundred feet from the middle line of said waters, nor nearer than two hundred and fifty feet to the shore line.

Sec. 2. Any person who shall violate any of the provisions of this act shall be guilty of a misdemeanor, and shall upon conviction thereof, be punished by a fine of not less than \$25.00 nor more than \$100.00 and costs of prosecution.

Sec. 3. This act shall take effect and be in force from and after April 1st, 1909.

CHAPTER 66-H. F. No. 758.

An Act requiring non-residents of Minnesota to take out a license for trapping mink, muskrat, otter and beaver in this state.

Be it enacted by the Legislature of the State of Minnesota:

Non-residents to secure license.—Section 1. Every person not a resident of this state is prohibited from trapping mink, muskrat, otter and beaver in this state unless he shall have first procured a license therefor from the game and fish commission. Such commission shall upon application issue to any non-resident a license to trap mink, muskrat, otter and beaver, upon the payment of a license fee of ten dollars (\$10.00), which license shall expire on the 31st day of December following its issuance.

Penalty for violation.—Sec. 2. Every person violating the provisions of this act shall be guilty of a misdemeanor.

Sec. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 67-H. F. No. 782.

An Act to repeal a special law regulating the salary of county attorney of Goodhue County, Minnesota.

Be it enacted by the Legislature of the State of Minnesota:

Special law relating to salary of county attorney of Goodhue county repealed.—Section 1. Repealing a law relating to the salary of county attorney of Goodhue county.—That chapter eightythree (83) of the Special Laws of the year one thousand eight
