CHAPTER 240—H. F. No. 1030.

An act fixing the salary of county commissioners in counties now or hereafter having not less than thirty-eight not more than forty-two congressional townships and now or hereafter having a taxable valuation of not less than ten million dollars.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Salaries of county commissioners in certain counties.—In each county of this state now or hereafter containing not less than thirty-eight (38) nor more than forty-two (42) congressional townships and now or hereafter having a taxable valuation of not less than ten million dollars as finally equalized by the state tax commission each year, the several members of the county board shall receive a salary of \$400 per year to be paid in twelve equal installments which shall be in full for all services upon the county board and committees thereof.

Sec. 2. *Per diem and mileage.*—Each member of such county board shall also receive three dollars per day for each and every day necessarily occupied in the discharge of their official duties while acting on any committee under the direction of the board, and ten cents per mile each way for every mile necessarily traveled in attending such committee work, and shall also be entitled to mileage of ten cents per mile each way for every mile necessarily traveled for attending meetings of the board, not to exceed twelve meetings in any one year; and in addition, the chairman if the county board shall receive ten cents per mile each way for going to the county seat to sign warrants during recess of the county board.

Sec. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 241—H. F. No. 1125.

An act to amend Section 1, Chapter 186, General Laws of Minnesota 1907, relating to phonographic reporters, as amended by Chapter 175, General Laws of Minnesota 1915.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Salaries of court reporters in certain districts.—That Section 1, Chapter 186, General Laws of Minnesota 1907, as amended by Chapter 175, General Laws of Minnesota 1915, be amended so as to read as follows:

Section 1. That each judge of any judicial district in this state which comprises, or which may hereafter comprise, a single county of *three hundred and eighty thousand (380,000)* inhabitants or over, may appoint a phonographic reporter, who shall be well skilled in his profession and competent to discharge the duties required, and who shall be a sworn officer of said court, and shall hold his office during the pleasure of said judge so appointing him. The salary of said reporter shall be *three thousand five hundred (\$3,500.00)* dollars per annum, payable in *semi-monthly* installments by the county treasurer of the county comprised in such judicial district, from any funds in his hands not otherwise appropriated.

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 242—S. F. No. 113.

An act to amend Chapter 400, General Laws for 1919, relating to game and fish.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Open season for game birds.—Section 54 of Chapter 400, of the General Laws for the year 1919, is hereby amended to read as follows: Mourning dove, prairie chicken or pinnated grouse, whitebreasted or sharp-tailed grouse, and upland plover may be taken or possessed between September 16th and October 1st, following, both inclusive, and woodcock may be taken or possessed between October 1st and November 30th, both inclusive. No mourning dove shall be taken, killed or had in possession prior to September 16, 1920, no woodcock prior to October 1, 1920, and no upland plover prior to September 16, 1927, no prairie chicken or sharp-tailed grouse shall be taken or killed or had in possession prior to September 16, 1921 and thereafter may be taken only in odd numbered years.

Sec. 2. That Section 55, Chapter 400, S. L. 1919 be amended so as to read as follows:

“Section 55. Limit.—A person may take, during the open season not to exceed 9 mourning doves, prairie chicken or pinnated grouse, white-breasted or sharp-tailed grouse, woodcock, or upland plover, in the aggregate of all kinds in one day.

No person shall take more than 30 of the game birds enumerated
