

## CHAPTER 263—S. F. No. 955.

*An act relating to foxes kept in captivity for breeding purposes, prohibiting unauthorized approaching or entering enclosures holding the same and providing penalties therefor.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Fox farms may not be entered.—From and after the passage of this act it shall be unlawful for any person without the consent of the owner, lessee or caretaker of a ranch or other enclosure in this State where foxes are kept in captivity for breeding purposes, to enter upon the private grounds belonging to or under the control of the owner or owners of said animals, within a distance of twenty-five yards from the outer fence or enclosure or to pass within, through or over the outer fence or enclosure within which the pens or dens of said animals are located and upon which said fence or outer enclosure notices forbidding trespassing on the said premises are kept posted so as to be plainly discernible at the said distance of not less than twenty-five yards. Provided, however, that the act shall not apply to such enclosure erected within twenty-five yards of any public highway or within twenty-five yards of any land adjoining the land upon which such enclosure may be or is erected.

Sec. 2. Violation a misdemeanor.—Any person violating any of the provisions of this act shall be guilty of a misdemeanor.

Sec. 3. This act shall take effect and be in force from and after its passage.

## CHAPTER 264—S. F. No. 975.

*An act authorizing the county board of any county in this state now or hereafter having taxable property of over \$300,000,000 and an area of over 5,000 square miles to appropriate and expend not more than \$10,000 from the general revenue fund of said county to defray the cost of furnishing and installing a suitable memorial in memory of the soldiers, sailors and marines of the World War.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Certain counties may erect memorial to soldiers and sailors.—The County Board of any County now or hereafter having taxable property of over three hundred million (\$300,000,000) Dollars and area of over five thousand (5,000) square miles, is hereby authorized to appropriate and expend from the general revenue fund of said county a sum not exceeding Ten thousand (\$10,000) Dollars to defray the cost of providing and installing a suitable memorial in memory of soldiers, sailors and ma-

rines of the nation, who served in the World War and were citizens or employes of the County at the time of entering such service, which memorial may be installed in the Court House of any such county at the county seat thereof.

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 265—S. F. No. 979.

*An act fixing clerk hire in the register of deeds office in counties of this state having a population of not less than 23,000, nor more than 27,000 inhabitants, and having an assessed valuation of not less than \$22,000,000 nor more than \$30,000,000, and having not less than 22 nor more than 24 congressional townships, and where the register of deeds office does not have a tract index system.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Clerk hire in register of deeds office in certain counties.—That in all counties of this state having a population of not less than 23,000 nor more than 27,000 inhabitants, and having an assessed valuation of not less than \$22,000,000 nor more than \$30,000,000, and having not less than 22 nor more than 24 congressional townships, and where the register of deeds office does not have a tract index system, the board of county commissioners may allow the register of deeds for deputy and clerk hire in an amount not to exceed \$1500 per annum, to be paid monthly out of the county treasury upon the order of the county auditor, and no allowance for such clerk hire shall be made or received, except for services actually rendered.

Sec. 2. Application.—This act shall not apply to counties wherein the salaries and clerk hire of county officials are fixed by special law.

Sec. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 266—S. F. No. 963.

*An act authorizing the governing body or school board of any corporation or school district, the board of which has the power to purchase sites for school buildings without authority from the voters, to acquire sites for school buildings by condemnation under the right of eminent domain.*
