expense of special inspection as provided for in this section. The amount of such fees shall be due and payable immediately upon completion of each season's inspection, shall bear interest thereafter until paid at the rate of 7% per annum, and if not paid on or before December I following a penalty of 10% shall also be added and collected."

CHAPTER 380-S. F. No. 1122.

An act to amend Chapter 425, Session Laws of Minnesota, 1921, relating to the laying of water mains in cities of the fourth class, villages and boroughs and assessing the cost against abutting property, by adding thereto an additional Section to be known as Section 111/2.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Water mains in certain municipalities.—That Chapter 425, Session Laws of Minnesota, 1921, be amended by adding thereto following Section 11 a new section, to be known as Section 11½, as follows:

"Section 111/2. Whenever any such city, village or borough shall have heretofore caused water mains to be laid under a general bond issue and not by special assessment, to equalize the frontage assessments, the council may cause such existing mains, if they are of cast iron, to be examined by a competent engineer and if same are of suitable size and condition for continued use, such existing mains may be assessed against the property abutting thereon at an average cost of not to exceed eighty per cent. of the assessment spread against the abutting property for the extension of new mains and this assessment of not exceeding eighty per cent. shall be calculated by the engineers or other competent person, and such assessment shall be prepared and provision made for its collection as in the case of new mains.

A hearing shall be held on old main assessments at the same time as the hearing of the assessment of new mains and in all respects the action shall be the same as prescribed for the new mains."

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 381—S. F. No. 1165.

An act authorizing counties to appropriate money to aid in the construction of interstate bridges in certain cases.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. County board may appropriate money to aid in the construction of inter-state bridges.—The County Board of any county may appropriate and expend from its county road and bridge fund, including such sums as are alloted or apportioned to it from the state road and bridge fund, such sums of money as it may deem proper for the construction and maintenance, in conjunction with any adjoining state or any political sub-division thereof, of the one-half of a bridge across any river forming a boundary line between this state and any other state. Any such bridge when constructed as a terminus of an existing state road, or when constructed, with the approval of the Highway Commissioner, as the terminus of a road which is not a State road, shall be for all purposes regarded as state road construction by such county to the extent of the amount contributed.

Sec. 2. This act shall take effect and be in force from and

after its passage.

CHAPTER 382-S. F. No. 1186.

An act to amend Chapter 467 of the Session Laws of 1921 relating to education and state aid for schools.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Special aid for classes for deaf in public schools.

—That paragraph (a) of subdivision e of Section 10 of Chapter 467

of Session Laws of 1921, be amended to read as follows:

"(a) For deaf children, two hundred fifty dollars (\$250) for each such child, who is enrolled in a day school and who is a resident of a district maintaining such school, and four hundred dollars (\$400) for each child who is a non-resident of the district maintaining such school and whose resident district does not maintain such school; the additional one hundred and fifty dollars (\$150) to be paid for board and room of such non-resident child."

after its passage.

CHAPTER 383—S. F. No. 1204.

An act to appropriate money to Jacob E. Hiebert and David Vogt in payment to them of the Minnesota soliders' bonus.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Appropriation for soldiers' bonus.—That the sum of \$180 is hereby appropriated to Jacob E. Hiebert and the sum of \$110 is hereby appropriated to David Vogt, payable out of the
