Section 1. County board may appropriate money to aid in the construction of inter-state bridges.—The County Board of any county may appropriate and expend from its county road and bridge fund, including such sums as are alloted or apportioned to it from the state road and bridge fund, such sums of money as it may deem proper for the construction and maintenance, in conjunction with any adjoining state or any political sub-division thereof, of the one-half of a bridge across any river forming a boundary line between this state and any other state. Any such bridge when constructed as a terminus of an existing state road, or when constructed, with the approval of the Highway Commissioner, as the terminus of a road which is not a State road, shall be for all purposes regarded as state road construction by such county to the extent of the amount contributed.

Sec. 2. This act shall take effect and be in force from and

after its passage.

CHAPTER 382-S. F. No. 1186.

An act to amend Chapter 467 of the Session Laws of 1921 relating to education and state aid for schools.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Special aid for classes for deaf in public schools.

—That paragraph (a) of subdivision e of Section 10 of Chapter 467

of Session Laws of 1921, be amended to read as follows:

"(a) For deaf children, two hundred fifty dollars (\$250) for each such child, who is enrolled in a day school and who is a resident of a district maintaining such school, and four hundred dollars (\$400) for each child who is a non-resident of the district maintaining such school and whose resident district does not maintain such school; the additional one hundred and fifty dollars (\$150) to be paid for board and room of such inn-resident child."

Sec. 2. This act shall take effect and be in force from and

after its passage.

CHAPTER 383—S. F. No. 1204.

An act to appropriate money to Jacob E. Hiebert and David Vogt in payment to them of the Minnesota soliders' bonus.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Appropriation for soldiers' bonus.—That the sum of \$180 is hereby appropriated to Jacob E. Hiebert and the sum of \$110 is hereby appropriated to David Vogt, payable out of the

Soldiers' Bonus Fund, in payment to the said Jacob E. Hiebert and David Vogt of the Minnesota Soldiers' Bonus.

CHAPTER 384—H. F. No. 14.

An act entitled "An act authorising any married woman who may file as a candidate for any public office to use the prefix 'Mrs.' and the full name or initials of her husband, as such candidate."

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Married woman may use husband's name in affidavit of candidacy.—Any married woman who may hereafter file as a candidate for any public office under the laws of this state may use the prefix "Mrs." and the full name of her husband, or the initials of her husband's given name, in stating her own name on her affidavit of candidacy; and the proper state, county or municipal official in the preparation of the official ballot shall use such name as written on the affidavit of candidacy, in designating such candidate on said ballot.

Sec. 2. "This act shall take effect from and after its passage. Approved April 19, 1923.

CHAPTER 385-H. F. No. 271.

An act to establish the Pyschopathic Department of the Minnesota General Hospital and to provide for its control and administration and to appropriate money for its construction, equipment, and support.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Psychopathic department of the Minnesota General Hospital established.—An institution to be known as the "Psychopathic Department of the Minnesota General Hospital" is hereby established. It shall be erected, equipped, maintained, and administered for the care, observation, study, and treatment of defective persons as defined in existing statutes, and of such other persons as are afflicted or supposed to be afflicted with any other abnormal mental condition. It may conduct an outpatient service for the diagnosis, care, and treatment of cases less pronounced in type than those thought proper for hospital residence. It may conduct clinics, investigate conditions or conduct educational work in regard to mental disease and mental hygiene in any part of the state. Persons who are addicted to the use of habit forming drugs shall be proper patients for admission to and treatment in the Psychopathic Department.
