CHAPTER 92—S. F. No. 322.

An act to amend Section 4644 of the General Statutes of Minnesota for 1913, relating to the powers and duties of the State Board of Health and local boards of health and providing a penalty.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Duties of local boards of health. Penalties.— Section 4644 of the General Statutes of Minnesota for 1913 is here-

by amended to read as follows:

Sec. 4644—All local boards of health and health officers shall make such investigations and reports, and obey such directions concerning communicable diseases, as the state board may require or give; and, under the general supervision of the state board, they shall cause all laws and regulations relating to the public health to be obeyed and enforced. When the state board shall have reason or cause to believe from its records or any other information in its possession that the provisions of this section are being or have been violated, the state board shall advise the Attorney General thereof giving the information in support of such belief, and the Attorney General, or under his directions, the County Attorney of any county in which the violation occurs shall forthwith Institute proceedings for the enforcement of the provisions Of this section and for the punishment of the violation thereof. Every member or officer refusing or neglecting to perform any duty imposed upon him by or pursuant to this chapter, or by any statute, ordinance, or by-law relating to the public health, shall be guilty of a misdemeanor.

Sec. 2. This act shall take effect and be in force from and after

its passage.

CHAPTER 93-S. F. No. 612.

An act authorizing and providing for the compensation of clerical help in offices of registers of deeds in counties now or hereafter having a population of not less than 29,000 nor more than 32,000 inhabitants and an assessed valuation of not less than \$29,000,000.00 nor more than \$32,000,000.00.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Register of deeds clerk hire in certain counties.—The county board of every county now or hereafter having a population of not less than 29,000 nor more than 32,000 inhabitants and an assessed valuation of not less than \$29,000,000.00, nor more than \$32,000,000.00, may by written order to be filed in the office of the county auditor authorize and allow such clerical help in said office as it may deem necessary in addition

to such help heretofore authorized by law, not to exceed \$900.00 per year.

Sec. 2. Application.—This act shall not apply to counties wherein the salaries of county officials are fixed by special law.

Sec. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 94-S. F. No. 813.

An act relating to personal property belonging to the state and providing for the sale, exchange or disposition thereof is certain cases.

Be it enacted by the Legislature of the State of Minnesota: Section 1. Personal property belonging to State may be sold.—Personal property belonging to the state, for which there is no immediate use, may be sold, exchanged or otherwise disposed of with the consent of the governor as follows: The official having custody and possession of such property shall apply in writing to the governor for his consent to sell, exchange or otherwise dispose thereof, and in his application shall describe the property and shall state the terms or conditions upon which it is desired to dispose of the same. The governor shall then refer the application to the purchasing agent of the state board of control for his recommendation. Thereafter, if the governor finds that there is no immediate use for such property and that the best interests of the state will be subserved by the sale, exchange or other disposition of such property, he may order that such property be sold, exchanged or otherwise disposed of, and in his order may provide for such terms and conditions as in his judgment will be for the best interests of the state. Any moneys received from the sale of personal property belonging to the state shall be paid into the state treasury and accredited to the general revenue fund.

Sec. 2. This act shall take effect and be in force from and

after its passage.

CHAPTER 95-S. F. No. 1006.

An act to provide for the preparation and publication of a compilation of the General Statutes of Minnesota and for the purchase by the State of Minnesota of sufficient copies thereof for the use of county officers and the various departments of the state.
