more closely cemented, in the interest of the common welfare; and, BE IT FURTHER RESOLVED, That the delegates from Minnesota be requested to present a copy of these resolutions to the officials of the Government of Sweden and to the officials of the exposition at Gothenburg, and convey to them the cordial felicitations and sincere greetings of the people of Minnesota.

## RESOLUTION No. 12.

A joint resolution relating to the withdrawal from sale of state lands bordering on or adjacent to meandered lakes and other public waters and water courses and the live timber growing or being thereon.

Whereas, In order to protect the public and in the interests of future generations, the state auditor as ex-officio land commissioner, has by office rule heretofore withdrawn and withheld from sale all state lands immediately adjacent to meandered lakes, and the live timber standing thereon, but the demand that such lands and timber be offered for sale is strong and persistent.

THEREFORE BE IT RESOLVED, That the action of the state auditor in so withdrawing and withholding said lands and timber from sale

be and the same hereby is approved and confirmed, and

BE IT FURTHER RESOLVED, that the state auditor be and he hereby is directed to withdraw and withhold from sale all state lands bordering on or adjacent to meandered lakes and other public water courses and waters and the live timber growing or being thereon.

## RESOLUTION No. 13.

A concurrent resolution memoralizing the federal government to construct in Minnesota a 500 bed tubercular hospital for the care of tubercular persons who served in the world war.

WHEREAS, The records of the United States Veterans Bureau for the Tenth Rehabilitation District, under date of November 26th, 1922, show a total of 343 tubercular veterans of the World War hospitalized in various hospitals in Minnesota; and

WHEREAS, The same report shows an additional number of 1964 tubercular cases of such service persons on file in the District Office of which more than 57 per cent are from Minnesota alone:

and

WHEREAS, There is no Government Hospital in the Tenth Rehabilitation District comprising the States of Minnesota, North Dakota, South Dakota and Montana, specializing in the care of such tubercular cases; and

WHEREAS, The reports of the State Board of Control for the fiscal year ending June 30, 1922, show that State Institutions specializing in such cases are overcrowded; and

WHEREAS, The program of contracting such cases out to vari-

ous contract hospitals is inadvisable,

THEREFORE BE IT RESOLVED by the State Senate of the State of Minnesota, the House of Representatives concurring, that we urge the immediate allocation of moneys and the prompt construction by the Government of a 500 bed tubercular hospital to be situated in a suitable location in the State of Minnesota, and that a central vocational training school be established in connection with such hospital.

BE IT FURTHER RESOLVED, that a duly authenticated copy of this resolution be transmitted to the President of the United States, the Coordinator and members of the Federal Board of Hospitalization, the Director of the United States Veterans Bureau. Washington, D. C. and to each Representative of the State of Minnesota

in the United States Senate and House of Representatives.

## RESOLUTION No. 14.

A concurrent resolution memorializing the federal government to begin immediately the construction of a neuro-psychiatric hospital at Saint Cloud.

WHEREAS. The Federal Government has already allocated the sum of \$1,225,000 for the purpose of building a neuro-psychiatric hospital in the Tenth Rehabilitation District; and

nospital in the Tenth Renadmentation District, and

WHEREAS, The City of Saint Cloud has by popular subscription and otherwise, raised a sum sufficient for the purchase of a site of 316 acres for such a purpose, such site having been duly accepted by the Government; and

WHEREAS, more than thirty-eight hundred (3800) neuropsychiatric cases from the State of Minnesota alone, which number represents more than 63 per cent of all such cases in the Tenth Rehabilitation District, are now on file in the District office of the United States Veterans Bureau; and

WHEREAS Statistics show that such cases have increased and are still increasing at the alarming rate of over three hundred per

month for the District: and

WHEREAS, There is no Government Hospital especially built or equipped for such cases in the State of Minnesota, nor in any of the other three states of the Tenth Rehabilitation District,

THEREFORE, BE IT RESOLVED, by the Senate of the State of Min-
