

## CHAPTER 100—S. F. No. 534.

*An act entitled "An act to legalize certain proceedings for the drainage of lands and county bonds issued or to be issued in connection therewith."*

Be it enacted by the Legislature of the State of Minnesota:

**Section 1. Certain drainage proceedings legalized.**—That in all cases where in a proceeding instituted under Chapter 230, Laws 1905, or its amendments, a ditch in one county has heretofore been established by order of the District Court, or of a judge thereof, after an appeal from an order of a county board refusing to establish the same on petition to it, and a contract for the construction of such ditch has been let, and a lien statement under General Statutes 1923, Section 6705 also known as G. S. 1913, Sec. 5544, in respect thereto been filed and recorded, and no appeals are pending, all proceedings in reference to said ditch already or hereafter had, including the issuance of the county's bonds to defray in whole or in part the expenses incurred or to be incurred in locating, constructing and establishing the same, are hereby legalized and validated.

Sec. 2. The provisions of this act shall not apply in the case of any pending litigation.

 CHAPTER 101—S. F. No. 636.

*An act amending Section 5681, General Statutes 1923, relating to the publication of session laws.*

Be it enacted by the Legislature of the State of Minnesota:

**Section 1. Publication of Session Laws.**—That Section 5681, General Statutes 1923, be and the same hereby is amended to read as follows:

5681. As soon as practicable after the adjournment of each legislative session, the laws and joint resolutions passed thereat shall be published by the printing commission in the general form heretofore adopted, with suitable headlines and marginal notes, and shall be indexed by the secretary of state with the assistance and advice of the attorney general, and each volume of such session laws shall have a full and complete index of the laws of said session, each index of each volume of session laws hereafter published to give briefly subject matter of law, reference to year, chapter and section of session laws and to sections of the Revised Laws of 1905 altered, amended or repealed, and a reference by chapter and year to the session laws of 1905 and subsequent years altered, amended or repealed. *Whenever any law enacted by the Legislature amends a*

*statute contained in a compilation of the General Statutes of the state but fails to refer to the section of such last compilation of General Statutes, the secretary of state with the assistance and advice of the attorney general shall note at the head of the law as printed the number of the section of the General Statutes in which the amended law is contained. Unless otherwise prescribed by law, the number of copies, and the manner and terms of disposing of the same, shall be determined by the commission; provided, that one hundred copies shall be assigned to the state university for the use of its law library; and, if the Legislature shall appropriate money for the publication of such session laws in the newspapers, the commission shall apportion the same equitably among such qualified newspapers as may make publication thereof within a time and in a manner by it directed or approved.*

Sec. 2. This act to take effect and be in force from and after its passage.

#### CHAPTER 102—H. F. No. 918.

*An act to fix the time of holding the general terms of district court in the Ninth Judicial District of the State of Minnesota.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Terms of Court in Ninth Judicial District.**—The general terms of the district court in the several counties constituting the Ninth Judicial District of the State of Minnesota shall be held at the time herein prescribed, as follows:

Brown County: On the 3rd Monday in May and the 4th Monday in November.

Lincoln County: On the 3rd Monday in March and the 4th Monday in September.

Lyon County: On the 1st Monday in June and the 3rd Monday in November.

Nicollet County: On the 1st Tuesday in May and the 2nd Tuesday in October.

Redwood County: On the 3rd Monday in April and the 4th Monday in October.

Sec. 2. **Laws repealed.**—All inconsistent Acts and parts of Acts inconsistent herewith are hereby repealed.

Sec. 3. **Effective July 1, 1925.**—This act is to take effect and be in force from and after July 1, 1925.
