That parties to any policy of life insurance now or hereafter issued shall have the right at any time to mutually agree in writing for an extension of time in which to pay a second or subsequent premium on said policy, upon condition that the failure to pay said amount agreed upon at the time agreed, shall lapse the policy as of the date mutually agreed upon in said writing, provided, that no such agreement shall impair any right to extended or paid up insurance which the insured may have under said policy nor any right to have the premiums, any part thereof or the amount payable for such extension charged against the policy under the terms of the policy. No such agreement need be attached to or made a part of the insurance policy so affected.

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 344-S. F. No. 1095

An act to amend Section 157, General Statutes 1913, as amended by Chapter 222, General Laws 1923, being a portion of Section 162 General Statutes 1923, relating to counties composing the Fifteenth Judicial District and fixing the times of holding general terms of district court therein.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Terms of district court in fifteenth judicial district. --That Section 157, General Statutes 1913, as amended by Section 2 of Chapter 222, General Laws of 1923, being a portion of Section 162, General Statutes 1923, be and the same hereby is amended so as to read as follows:

"157. The general terms of the district court shall be held each year in the several counties constituting the fifteenth judicial district of Minnesota, at the times herein prescribed, as follows:

Aitkin county, on the third Tuesday in February and the second Tuesday in September.

Beltrami county, on the second Tuesday in February and the second Tuesday in September.

Cass county, on the third Tuesday in June and the second Tuesday in December.

Clearwater county, on the second Tuesday in April and on the first Tuesday in October.

Crow Wing county, on the first Tuesday in May and the first Tuesday in November.

Hubbard county, on the first Tuesday in June and the first Tuesday in December.

Itasca county, on the third Tuesday in March and the second Tuesday in Scptember.

Koochiching county, on the first Tuesday in May and the first Tuesday in October.

Lake of the Woods county, on the second Tuesday in June and the first Tuesday in December."

CHAPTER 345-S. F. No. 1114

.1n act to amend Section 2, of Chapter 9, General Laws 1917, relating to the time of holding general terms of the district court in the county of Kanabec in the nineteenth judicial district.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Terms of district court in nineteenth judicial district.—That Section 2 of Chapter 9, General Laws 1917, the same being the last paragraph of Section 162, General Statutes 1923, be and the same hereby is amended so as to read as follows:

"Sec. 2. In addition thereto general terms of court shall be held in Kanabec county on the *fourth* Tuesday in January, on the fourth Tuesday in March and the third Wednesday in June, for the trial and determination of both criminal and civil cases, but no grand or petit jury shall be drawn or summoned unless the court shall so direct by a written order made and filed with the clerk of court of the county, at least twenty days before the dates herein fixed for holding said court."

CHAPTER 346-S. F. No. 1204

An act to fix the amount of clerk hire of county treasurers in counties now or hereafter containing not less than 12 nor more than 13 congressional townships and an assessed valuation of not less " than eight nor more than ten million dollars.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Clerk hire of County Treasurer in certain counties.—In every county now or hereafter containing not less than 12 nor more than 13 congressional townships, and an assessed valuation of not less than eight nor more than ten million dollars, the county treasurer may be allowed for clerk hire, in the discretion of the county board, a sum not exceeding \$900.00 per year, to be fixed by said board at any regular meeting thereof.
