dollars; three. seventy-five dollars; four, one hundred dollars; five, one hundred thirty dollars; six, one hundred sixty dollars; seven, two hundred dollars; eight, two hundred fifty dollars; nine, three hundred twenty dollars; ten, four hundred dollars; eleven, five hundred dollars; twelve, six hundred dollars; thirteen, seven hundred dollars; fourteen, eight hundred dollars; fifteen, nine hundred dollars; sixteen years where not otherwise authorized by law, one thousand dollars, and shall be payable to the estate of the child or to the person or persons responsible for the support of the child and named as beneficiary in the certificate."

Sec. 2. Law repealed.—Section 6, Chapter 20, Laws 1919, is hereby repealed.

CHAPTER 278-S. F. No. 668.

An act authorizing University of Minnesota to convey to the Summit Cemetery Association of Morris, Minnesota, certain parccls of land in the County of Stevens, State of Minnesota, in exchange for other parcels of land, in said County.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. State University to convey certain lands.— University of Minnesota is hereby authorized and empowered to grant, bargain, sell and convey to the Summit Cemetery Association of Morris, Minnesota, the following parcel of land in the County of Stevens, State of Minnesota, to-wit:

All that part of Sections 35 and 36 Township 125 North, Range 42 West of the Fifth principal meridian more particularly described as follows, to-wit:

Beginning at a point 440 feet West and 100 feet North of the quarter section corner common to said sections 35 and 36 and running South 100 feet; thence East 670 feet; thence North 560 feet to the right of way of trunk highway No. 28; thence Southwesterly along said right of way to the point of beginning, and containing about five acres of land.

The parcel of land above described in this section shall be conveyed by warranty deed free from encumbrances.

Sec. 2. University of Minnesota in order to round out its present campus and to make more contiguous and rectangular its land holdings at the West Central School of Agriculture, is hereby authorized and empowered to acquire in exchange for sa.d parcel of land and as consideration therefor from the Summit Cemetery Association of Morris, Minnesota, the conveyance, by warranty deed, free from encumbrances of the following described parcel of land in said County of Stevens, to-wit: All that part of Section 36 in Township 125 North of Range 42 West of the Fifth principal meridian more particularly described as follows, to-wit:

Beginning at a point 230 feet East of the quarter section corner common to Sections 35 and 36 of said Township and Range, and running East 430 feet, thence South 495 feet, thence West 430 feet, thence North 495 feet to the place of beginning containing approximately five acres of land.

CHAPTER 279-S. F. No. 738.

An act exempting the commissioner of forestry and fire prevention and all his employes from jury service during the period of such service or employment.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Certain officers and employees exempt from jury duty.—The commissioner of forestry and fire prevention under Chapter 426, Laws 1925, and all persons at any time employed by him, or under his direction, are hereby exempted from jury service during the period of such service or employment. No person hereby exempted shall be drawn on, or have his name placed in any list of persons eligible to jury service in any court.

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 280-S. F. No. 740.

An act authorizing the commissioner of forestry and fire prevention to contract for or accept the services of, and to issue commission or other evidences of authority to, persons whose scrvices he desires in forestry or fire prevention work.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Commissioner of forestry to procure aid.—The commissioner of forestry and fire prevention under Chapter 426, Laws 1925, is hereby authorized and empowered to contract for or accept the services of any and all persons whose aid is available, temporarily or otherwise, in forestry or fire prevention work either gratuitously or for compensation not in excess of the limits now or hereafter provided by law with
