CHAPTER 428—H. F. No. 1322

An act to appropriate money for the conservation and development of the state's natural resources; for the establishment, maintenance, improvement and enlargement of certain state fish hatcheries, and for land for the same; for maintenance and improvement of state soldier's home; for the maintenance of Minnesota Department, G. A. R.; for expense of burial of soldiers and sailors; for maintenance, improvement and repairs, Minnesota State Agricultural Society; for county and district agricultural societies; for aid to agricultural agents; for various stock breeders', dairymen's, horticultural and poultry associations and societies, farmers' institutes; for public parks and additions thereto and for the establishment of new

public parks; for sheriff's per diem and mileage in certain cases; for wolf bounties; for drainage and highway assessments upon state lands; for vessel tonnage tax; for fees public land collections; for aid to Minnesota Tourist Bureau; for maintenance Sibley House; for maintenance of various semi-state activities; for the erection of certain monuments; and to appropriate money from the state prison revolving fund to aid in the construction of a suitable barge terminal at Stillwater; for maintenance of various state departments and for other purposes.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Appropriation for general state activities.—The sums hereinafter named, or so much thereof as may be necessary, are hereby appropriated from any moneys in the State Treasury not otherwise appropriated, for the purposes specified, in the following sections of this act, to be available, when not otherwise stated, for each of the fiscal years ending June 30, 1930, and June 30, 1931.

Provided, that the Minnesota State Poultry Association (being a consolidation of the Minnesota State Poultry Association of Hennepin County and the Minnesota Fanciers Association of Ramsey County) shall receive not to exceed \$800.00 subject, however, to all other provisions relating to the distribution of the appropriation herein made.

Provided, that no one association or society shall receive an amount greater than the annual premiums paid to exhibitors by them and shall not in any case exceed the sum of four hundred dollars (\$400.00) to any one county. Provided,

further, that any society or association to be entitled to their distributive share of this appropriation shall file annually with the state auditor, on or before the first day of April of each year, a sworn statement signed by the president or secretary of such association or society, showing the amount of cash premiums paid during the year to exhibitors, and the amount to be distributed to such society or association from said fund shall be based and determined upon the amount of cash premiums paid out as hereinbefore provided. Provided, further, that where there is more than one association in a county the amount allotted to such county, not exceeding four hundred dollars (\$400.00) aforesaid, shall be distributed to the societies in equal amounts.

Sec. 12. Balances Transferred.—There is hereby transferred to the Revenue Fund out of the Game and Fish Account the sum of \$116,233.76. Unexpended balances in all appropriation accounts of the Commissioner of Game and Fish, except Game and Fish, State Fish Revolving, Fish Lake Improvement Revolving, Fins, Feathers and Furs and Predatory Animal Control are hereby directed to be cancelled by the State Auditor.

Sec. 13. Appropriations for barge terminal.—The sum of Twenty Thousand Dollars (\$20,000) is hereby appropriated from the State Prison Revolving Fund to be expended and contributed by the State Board of Control in aid of the construction of a suitable river barge terminal at Stillwater, and the Board of Control is authorized to pay such sum so appropriated to the City of Stillwater in aid of the construction of such barge terminal. Provided that such payment shall not be made until the Inland Waterways Corporation shall have extended barge service upon the St. Croix River to Stillwater and until in the opinion of the Board of Control suitable provision has been made for sufficient additional funds to construct such terminal.

Sec. 14. Unexpended balance reappropriated.—The unexpended balance of moneys appropriated by Chapter 382, Laws of 1927, is hereby credited to the Minnesota Bank Tax Commission. Said Commission is authorized to pay any liabilities of the Commission created by said Chapter 382, Laws of 1927.

Sec. 15 Unexpended balance reappropriated.—The unexpended balances on June 30, 1929, in the several appropriations heretofore made to the activities named in this act are hereby reap-

propriated and made available for the fiscal years ending June 30, 1930, and June 30, 1931, respectively, for the purposes for which such appropriations were made. Where an appropriation is made in this act and there remains a balance in a previous appropriation for the same purpose, such balance shall be added to and become a part of such appropriation, except as herein otherwise specifically provided.

Sec. 16. This act shall take effect and be in force from and after its passage.

CHAPTER 429—S. F. No. 3

An act entitled "An act proposing an amendment to Section 3, of Article 10, of the Constitution of the State of Minnesota, authorizing the Legislature to prescribe and limit the liability of stockholders in corporations."

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Amendment proposed.**—The following amendment to Section 3, of Article 10, of the Constitution of the State of Minnesota, is hereby proposed to the people of the State for their approval or rejection, which amendment, when so adopted, shall read as follows:

"Sec. 3. The Legislature shall have power from time to time to provide for, limit and otherwise regulate the liability of stockholders or members of corporations and co-operative corporations or associations, however organized. Provided every stockholder in a banking or trust corporation or association shall be individually liable in an amount equal to the amount of stock owned by him for all debts of such corporation contracted prior to any transfer of such stock and such individual liability shall continue for one year after any transfer of such stock and the entry thereof on the books of the corporation or association."

Sec. 2. **To be voted on general election.**—This proposed amendment shall be submitted to the people of this State for their approval or rejection at the general election for the year 1930, in the manner provided by law and the Secretary of State shall place this
