Sec. 2. - **Law repealed.**—Section 5687, General Statutes 1923, is hereby repealed.

Sec. 3. **Provision separable.**—In case any section, subdivision, paragraph or sentence of this act is declared unconstitutional, that shall not affect the validity of the rest of this act.

Sec. 4. **Effective July 1, 1931.**—This act shall take effect and be in force from and after July 1, 1931, but shall not affect any action or proceeding now pending in any court.

CHAPTER 115—H. F. No. 516

An act to appropriate money for the current expenses, buildings and improvements at state institutions, for expenses of the state board of control and certain activities under the supervision or control of said board, and for other purposes; to appropriate money from the state prison revolving fund for current expenses, buildings and improvements at the state prison; to authorize the transfer of funds in certain cases; to extend balances of appropriations heretofore made and to authorize the executive council to borrow money in certain cases.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Appropriation for state institutions, etc.**—The sums hereinafter named, or so much thereof as may be necessary, are hereby appropriated from any money in the state treasury not otherwise appropriated to be expended by the state board of control for the purposes specified in the following sections of this act, to be available at the time designated opposite each item.

Provided that for the years ending June 30, 1932, and June 30, 1933, respectively, the state board of control is authorized, by and with the approval of the state auditor, to transfer in cases of necessity a portion of the funds appropriated for the current expense of any one of the following institutions, namely: The Anoka State Asylum, the Hastings State Asylum, The Willmar State Asylum, the Fergus Falls State Hospital, the Rochester State Hospital, the St. Peter State Hospital, the School for Feeble-Minded, the Colony for Epileptics, the School for the Blind, the School for the Deaf,

the State Public School, the State Training School, the Home School for Girls, the State Reformatory, the State Reformatory for Women, the Sanatorium for Consumptives, and the Hospital for Crippled Children, to the use of any other of the aforesaid institutions; and it is further authorized, by and with the approval of the auditor, to use the sums not exceeding in the aggregate of five thousand dollars (\$5,000), where necessary to supplement the appropriations for current expenses of any of the above named institutions; and

Provided further, that said board may, without such consent and approval of the auditor, use the balance of any appropriation made for a specific purpose at any institution for any other specific purpose in and about such institution after the purpose for which such appropriation was made has been accomplished; and

Provided further, that said board is hereby authorized and empowered to set aside a portion of the current expense fund of any such institution to be used as a diversified labor fund for the introduction and encouragement of such industries as in its judgment may be beneficial to the inmates of such institution.

Sec. 20. State prison revolving fund.—The sums hereinafter named, or so much thereof as may be necessary, are hereby appropriated from any money in the state treasury to the credit of the state prison revolving fund to be expended by the state board of control for the purposes specified in this section, to be available at the time designated opposite each item.

Sec. 21. Unexpended balances appropriated.—The unexpended balances on hand June 30, 1931, in the several appropriations for each and all of the institutions hereinbefore named, the

state board of control and several divisions and activities of said board are hereby reappropriated for the fiscal years ending June 30, 1932 and June 30, 1933, and where an appropriation is made in this act and there remains a balance in a previous appropriation made for the same purpose, such balance shall be added to and become a part of such appropriation.

Sec. 22. **Executive Council may borrow funds.**—Whenever it becomes necessary, in order to meet the current demands upon the revenue fund for the payment of appropriations, the executive council, may at any time prior to June 30, 1933, make such agreement with banks or other corporations or persons as they may deem advisable or necessary to pay warrants issued against said revenue fund pursuant to any such appropriation prior to the time when the money to meet such appropriation comes into the state treasury, and whenever any warrants so issued are paid for the accommodation of the state the money necessary to pay interest upon the amounts of such warrants from the time when such payment was made until the money to redeem such warrants comes into the state treasury, at the rate agreed upon by the said executive council is hereby appropriated.

Sec. 23. This act shall take effect and be in force from and after its passage.

CHAPTER 116—H. F. No. 569

An act to amend General Statutes 1923, Section 5800, as amended by Laws 1929, Chapter 93, relating to qualifications for examination for registered pharmacists.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Examination for pharmacists.**—That General Statutes 1923, Section 5800, as amended by Laws 1929, Chapter 93, be and the same is hereby amended so as to read as follows:

“5800. To be entitled to examination by the board as a pharmacist, the applicant shall be at least 21 years old and shall be a graduate of a college or school of pharmacy recognized and approved by, or a member of, the American Association of Colleges of Pharmacy, and shall have had at least one year of practical experience in drug stores where physician's prescriptions are usually compounded.
