CHAPTER 274—S, F. No. 1123

An act relating to the allowance for traveling expenses of members of the board of county commissioners in certain counties.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Expense of county board in certain counties.— The county commissioners of any county in this State having a population of not less than 24,000 nor more than 27,000, and having an assessed valuation of not less than \$18,000,000 nor more than \$23,000,000, exclusive of moneys and credits, and having not less than 22 nor more than 24 congressional townships, may be allowed and paid, in addition to the salaries fixed by law, their actual and necessary traveling expenses incurred and paid by them in the discharge of their official duties, as such expenses are defined and limited by Mason's Minnesota Statutes of 1927, Section 656; provided, however, that the total aggregate amount which may be allowed and paid to all the county commissioners of any such county as traveling expenses shall not exceed the sum of \$1600.00 per year.

CHAPTER 275-S. F. No. 1175

An act continuing the bank tax commission created pursuant to Chapter 38, General Laws of Minnesota for the year 1929, and appropriating money therefor.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Bank tax commission continued.—The Bank Tax Commission created pursuant to Chapter 38, General Laws of Minnesota for the year 1929, is hereby continued together with the members appointed pursuant thereto, with all the powers and duties provided for in said act until the end of the session of the legislature of this State beginning in January, 1933.

Sec. 2. Unexpended balance reappropriated.—There is hereby appropriated the unexpended balance to the credit of said commission of the appropriation made by said chapter 38, General

Laws of Minnesota for the year 1929, for the purposes of said commission as provided in said act, the same to be immediately available.

Sec. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 276-S. F. No. 1194

An act to permit the regulation by the school board of labor on public schools in any independent school district which is within the limits of any city of the second class.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Schools to make labor regulations.—That the school board of any independent school district which is within the limits of any city of the second class may adopt any ordinance duly enacted by the council of such second class city, including the penalty provisions for the enforcement thereof, relating to residence requirements, wage scales, and other regulations pertaining to labor on public works, and to require that it be a part of the specifications in contracts and be effective in all construction or repair work or any other public work involving the improvement of school property of such independent district.

Sec. 2. School board to adopt forms and methods.—That such school board may adopt and use the same forms and methods of regulating said ordinance as is used by the council of such city of the second class.

Sec. 3. To be additional powers.—That these powers shall be in addition to all other powers now vested in the school boards of an independent school district which is within the limits of any city of the second class.

Sec. 4. This bill shall be in force and effect from and after its passage.
