

CHAPTER 283—S. F. No. 758

An act relating to the state forests, and providing for setting apart therefor certain public lands of the state which have reverted to the state after a previous sale thereof.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Certain state lands to become state forest.—Whenever the Commissioner of Forestry and Fire Prevention shall determine that any tract of public land of the state which shall have reverted to the state on account of default after sale theretofore made to an individual purchaser, and which, after being re-offered for sale, remains unsold, is suitable and is required for use as a forestry administrative station, demonstration forest, or for any other forestry purpose, and which has heretofore been put to such use, all in designated state forests, and shall so certify to the State Auditor, it shall be the duty of the Auditor forthwith to certify such tract upon his records as state forest land. Thereupon any and all right of the prior purchaser of such tract to redeem the same shall be terminated and extinguished and such tract shall become and be a part of the state forests, subject to all the provisions of law relating thereto.

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 284—S. F. No. 818

An act relating to the salaries and clerk hire of certain county officers in counties now or hereafter having not less than 70 nor more than 80 full or fractional congressional townships and having at any time an assessed valuation of not less than \$2,000,000 and not more than \$5,000,000, exclusive of money and credits, and amending Laws 1921, Chapter 351.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Salary and clerk hire of county officers in certain counties.—That Laws 1921, Chapter 351, Section 1, be amended to read as follows :

“Section 1. In each county of this state now or hereafter containing not less than 70 full or fractional congressional townships and not more than 80 full or fractional congressional townships, and having at any time an assessed valuation of not less than \$2,000,000 and not more than five million (\$5,000,000) dollars, exclusive of money and credits, as officially equalized by the State Tax Commission, the salary and clerk hire of the county auditor, county treasurer, clerk of district court, and register of deeds and judge of probate respectively, shall be as hereinafter provided.”

CHAPTER 285—S. F. No. 901

An act to fix the time of holding the general terms of the district court in the fourteenth judicial district of the State of Minnesota.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Terms of district court in fourteenth judicial district.—The general terms of the District Court in the several counties constituting the Fourteenth Judicial District of the State of Minnesota shall be held, each year, at the times herein prescribed as follows :

Pennington County: On the second Tuesday in January, and the second Monday in June.

Mahnomen County: On the fourth Monday in May.

Kittson County: On the fourth Monday in March, and the second Monday in November.

Roseau County: On the second Monday in April, and the fourth Monday in October.
